ORDER


NO.F. 1(12)/DC/MC/2014/572-652. In partial modification to the Executive order No.F.1 (12)/DC/MC/2014 dated the 21st April, 2014 issued in compliance of the directions given in the judgment dated 14-02-2006 by the Hon'ble Supreme Court of India in the case title Smt. Seema Vs. Ashwani Kumar in Transfer Petition (C) No. 291 of 2005.

And whereas, in compliance thereof and also to consolidate the law governing registration of marriage in Delhi and to maintain procedural uniformity, the Lt. Governor of National Capital Territory of Delhi is pleased to issue executive directions and amend the said order for compulsory registration of marriages solemnized in the Union Territory of Delhi as following, namely:-

Short title extent and commencement:


1. (1) This order is called the Delhi (Compulsory Registration of Marriage) Amendment Order, 2016.
(2) This Order shall come into effect on the date of its notification in the Delhi Gazette.
2. Amendment of para-4 In the said order, in para 4, in sub para (b), for the words "two hundred" the words "five hundred" shall be substituted.
3. Amendment of para 10 – In the said order, in para 10, for the words "ten thousand" the words "One thousand" shall be substituted.
