Sir/Madam,

Please find enclosed herewith a copy of letter No.12013/3/2012-K.V dated 28th January, 2013 addressed to the Chief Secretary, Govt. of NCT of Delhi issued by the Dy. Secretary to the Govt. of India, Ministry of Home Affairs, Govt. of India, Department of J&K Affairs, on the above mentioned subject in which it has been stated that the enhancement of cash relief to the Kashmiri Migrants in Delhi has been examined in the Ministry and decided to enhance the cash relief w.e.f. 1st July, 2012.

The existing rate of cash relief to the J&K migrants is Rs.1250/- per head per month subject to the ceiling of Rs.5000/- per month per family of four or more members which has been now enhanced by the Govt. of India, Ministry of Home Affairs, Department of J&K Affairs, to Rs.1650 per head per month subject to a ceiling of Rs.6600/- per family per month of four or more members.

You are, therefore, requested to take necessary action in the matter accordingly.

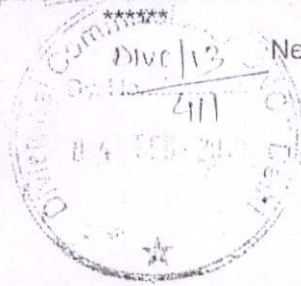
