



**CIRCULAR**

To simplify the process of issuance of OBC certificate the matter for requirement of the caste status attestation certificate from the two Gazetted Officers along with the application form for OBC Certificate was discussed in the Deputy Commissioner's meeting held on 3.9.2004 and decided that the caste status attestation certificate from the Gazetted Officer, Member of Parliament, MLAs, Councillors, etc., should be accepted as in the cases of issuance of SC/ST certificates. These instructions will take place with immediate effect. Rest of the instructions in respect of issuance of OBC certificates will remain unchanged and will be adhered to.


