Public Notice under Section 21 of the RFCTLARR Act, 2013

1. Whereas, earlier vide Notification No. ADM/LAC/SW/2015/12966 dated 25.02.2025 the land specified below was notified under Section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, for infrastructure project i.e. construction of Waste Water Treatment Plant (WWTP) which will treat the Waste Water Generated from the inhabitants of the Tajpur Khurd Village and adjoining areas and published by the Collector in the Part IV of the NCT of Delhi Gazette, dated 25 February, 2025 and also published in newspapers on 02 May, 2025 in Indian Express (English) and Amar Ujala (Hindi).
