PUBLIC NOTICE**

It is hereby informed that the land comprised in the Khasra No. 12 min and Khasra No. 13 min of Village Haiderpur, Shalimar Bagh, Delhi were acquired by the Government vide Award No. 40/80-81 and Award No. 50/80-81. Joint survey-cum-Nishandehi was carried out on 10/01/2026 and found that 143 unauthorised built-up structures, being used for residence and commercial purposes by unauthorised occupants, are falling within the ROW of Road No. 320, Village Haiderpur, Shalimar Bagh, Delhi with existing road width of 19.50 mts. only and unauthorized structures/encroachment on 10.50 mts. road width falling in Khasra no. 12 min. (2-17) & Khasra no. 13 min (5-01).

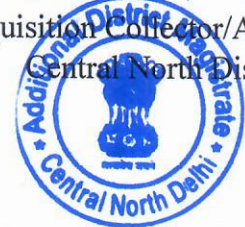
Therefore, all unauthorized occupants of the abovesaid unauthorized built-up structures in acquired land situated on Road No. 320, Village Haiderpur, Shalimar Bagh, Delhi are hereby called upon to show cause/submit objections, if any, **within 15 days** from the date of issuance of this notice, as to why possession of the above acquired land should not be taken for the purpose of road widening in public interest.

The written reply, along with documentary evidence and contact details, may be submitted before the **Additional District Magistrate (Central North) at the Office of the District Magistrate, Central North District, Rampura, Delhi-35**, or via email to **lac.centralnorth@gmail.com** or at the Special Camp to be conducted on **28.01.2026** and **29.01.2026** at **Sahib Singh Verma Community Hall, Shalimar Bagh, Delhi**.

In case of failure to submit any reply or sufficient justification/representation within the prescribed time, it shall be presumed that none of the unauthorized occupants of above acquired land has any lawful right/claim/interest over the said land and the competent authority shall proceed to take possession of the acquired land as per law.
