Dear Sir

As you aware, the Revenue Department handles sensitive matters related to Land Revenue, various Policy matters related to Aadhar, Certificates like Cast Certificate, Income Certificate, Marriage Certificate, Domicile Certificate etc. At the Headquarter level the Department organize and monitor various religious yatras / pilgrimages such as Mansarovar Yatra, Haj, Urs, Kanwar etc., Disaster Management Act is being implemented by the Headquarter through all various District Magistrates. Collection of Stamp Duties on various instruments is an important work which is mainly being handled at the Headquarter level.

In Headquarter, there are 04 SDMs who are supervising all the above mentioned works. During the 2013 Assembly Elections held in Delhi, the Revenue Headquarter had to face serious problem in getting important matters executed as all the 04 SDMs (HQ), on the direction of the ECI, were appointed Returning Officers, in place of the regular EROs, for conducting Elections.

It is worth mentioning that during the Election time, all the DCs, Area ADMs and SDMs are actively engaged in Election work which automatically leads to the Subordinate staff getting engaged in the Election Office. The SDMs working in Headquarter are constantly involved in the Election process by liasoning with different DCs, Divisional Commissioner and CEO, Delhi.



Further, as it is the financial year end and as most of the staff are either on transfer or on Election work, in case the SDMs at Headquarter are also put on active Election work the entire work of the Revenue Department will be paralysed.

In view of the above submission, I would request you to kindly intervene in the matter and issue direction to the CEO, Delhi not to engage the 04 SDMs posted in the Revenue Headquarter in the forthcoming Parliament Elections proposed to be held on May, 2014.
