GAON SABHA ADVOCATES EMPANELMENT ORDER

In supersession of earlier office order No. F.46/235/Dir(P)/ Panel/2018/4170-4295 dated 23.10.2019 as modified vide order of even No. dated 29.8.2022, 12.09.2023, the following panel of advocates is hereby constituted for contesting cases for and on behalf of Gaon Sabha/ Central Govt. (after urbanization) in the court of RA/SDM/Collector/ Dy. Commissioner in districts, court of Financial Commissioner, Delhi and District Courts. This panel shall come into force with effect from date of issue of this order. The period of this panel will be 3 (three) years extendable by 1 (one) year at the discretion of Additional Chief Secretary (Revenue)/ Divisional Commissioner, GNCT of Delhi.

The empanelment of advocates is subject to the following terms & conditions:-


1. The Govt. reserves its rights to strike off any advocates from the panel at any time without assigning any reason.
2. Where two or more suits together involves substantially identical question of law or facts, the fee for the main suit shall be paid in accordance with foregoing schedule but for the remaining suits fee at the half of the admissible fee for each suit irrespective of whether all the suits are heard together or not.
3. No separate fee will be payable for any miscellaneous application or proceedings taken in the same suit or appeal.
4. No fee shall be payable where no legal work is done but the counsel appeared for pending instructions.
5. Where union of India is a party along with Gaon Sabha in respect of the same suit, panel lawyer shall also represent the UOI but no separate fees for this representation shall be payable.
6. The panel Lawyer shall ensure that UOI is invariably made a party in all suits of Gaon Sabha.
7. The panel lawyer shall bring to the notice of the Dy. Commissioner/BDOs concerned and if necessary, to the notice of the court, the provisions of Acts/Rules/Regulations.
8. The lawyers will act as standing counsels for Gaon Sabha in the courts and if need arises, will accept the notice/s of Gaon Sabha.
9. The panel lawyers engaged for a case shall be incharge of the case entrusted to him. He/she will be required to advice the Gaon Sabha/Department at any time in a matter. He/She will also be required to submit a notice giving day to day progress in each case to the BDO concerned on the following day of hearing.
10. The counsel would take all steps in the litigation including acting and pleading and taking execution proceedings where cases are decided in favour of Gaon Sabha and obtaining and advising about the availability of filling the appeal where the cases are decided against the Gaon Sabha.

11. The panel lawyers will not be paid any retainer except the professional fee for conducting the case in additional clerkage of 10% and a fixed amount of Rs. 500/- or actual expenses, whichever is less, for court fee, talbana etc. paid out to his/her pocket.
12. No panel lawyer shall appear for parties against Gaon Sabha/UOI in any courts.
13. The fee shall be payable in three installments i.e. 1/3rd to be paid after some substantial action has been taken in the case i.e. filling of pleadings, written statements etc. 1/3rd on the conclusion of the hearing of the case and the balance fee after the case is decided and copy of judgment/decreed or order along with the opinion is furnished. Out of pocket expenses will however, be payable as and when they are incurred. Clerkage will be paid along with the last & final installment.
14. The tenure of panel advocates for Gaon Sabha cases shall be three years or till further orders extendable by one year at the discretion of the Divisional Commissioner.
15. The performance of the panel advocates will be reviewed annually by the SDM/DM/Director(Panchayat) to whose offices they would be attached.
16. The name of any advocate in the present panel can be deleted at any time on account of his/her non-performance or misconduct.
17. Remuneration/Fees payable will be as under:-

Suit for declaration for injection or declaration and injections irrespective of valuation in the courts of SDMs/RAs/Sub-judge/LACs.	Rs. 4000/-
Appellate court of Dy. Commissioner, Distt. Judge, Addl. Collector & Sr. Sub.Judges.	Rs. 5000/-
Appellate court of Financial Commissioner	Rs. 6000/-

Allotment of work to these panel advocates in the districts/ courts would be specified in the subsequent order.
