OFFICE MEMORANDUM

Sub: Issuance of Income and Asset Certificate to the Economically Weaker Sections (EWSs) in Delhi for direct recruitment in civil posts and services under Government of India.

Reference is invited to letter No.F.19(10)/2018/S.IV?766-767dated 22.03.2019 received from Services Department, Govt. of NCT of Delhi enclosing therewith O.M. No.36039/1/2019-Estt (Res) dated 31.01.2019 of DOPT, Govt. of India on the above cited subject (Annexure-I).

- 2. It has been directed by the Services Department, Govt. of NCT of Delhi vide above letter that, as the work related to Issuance of Income and Asset Certificate to economically weaker section for providing reservation in the direct recruitment in civil posts and services in Government of India comes under the domain of Revenue Department, appropriate action relating to issuance of Income & Asset Certificate and their verification etc. may be issued by the Revenue Department, Govt. of NCT of Delhi.
- 3. In the cited DoPT OM, the criteria of Income and Asset Certificate is stipulated as under:-
 - A The Income and Asset Certificate shall be issued to the persons belonging to EWSs who are not covered under any of the existing schemes of reservation for SCs/STs/OBCs (States/UTs & Central list)
 - B Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 lakh (Rupees Eight Lakh only) are to be identified as EWSs for benefit of reservation Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.
 - C Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-
 - i) 5 acres of agricultural land and above
 - ii) Residential flat of 1000 sq. ft and above;
 - iii) Residential plot of 100 sq. yards and above in notified municipalities;
 - Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
 - D The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
 - E The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.
- 4. Based on above cited DoPT OM, and other stipulations and after taking cue from all three State Govt. instructions and keeping in view the prevailing circumstances in GNCT of Delhi, following set of guidelines/process/ instructions for issuance of Income & Asset Certificates for EWS category is issued:-
 - 4.1 The concerned area SDM shall be the Issuing Authority in respect of Income and Assets Certificate of EWS Category in Delhi.



- 4.2 The Issuing Officer i.e. area SDM would issue the Income and Assets Certificate after carefully verifying all relevant documents, in the format placed (Annexure-II) based on the criterion as at para 3 above..
- 4.3 Applicants applying for issue of obtaining Income and Assets Certificate under EWS Category shall apply online only through e-District Portal of GNCT of Delhi, Department of Revenue, Govt. of NCT of Delhi.
- 4.4 The applicant shall apply in the application proforma which would be available on the e-District Portal.
- 4.5 The applicant shall also upload all the requisite documents as listed in the list of documents required for the issuance of the certificate as stipulated in application form prescribed (Annexure-III).
- 4.6 The Income & Asset certificate shall be issued by the Issuing Authority only after his complete satisfaction of the supporting facts/information submitted and due verification of such supporting facts/documents by the applicant
- 4.7 The Income & Asset certificate shall be issued online within 15 days from the date of receipt of application form duly completed in all respect to the satisfaction of the Issuing Authority.
- 4.8 The Issuing Authority shall examine the requisite information/facts provided by the applicant qua the eligibility criteria and satisfy himself that the applicant is eligible in all respects for obtaining Income & Assets Certificate for EWS Category as prescribed by Govt. of India vide O.M. dated 31.01.2019 as aforesaid.
- 4.9 It is relevant to mention here that in case of obtaining Income & Asset Certificate for EWS Category by any applicant by furnishing incorrect, false and fraudulent information in the application /documents uploaded/furnished for issuing the certificate, proceedings may be initiated against him under the relevant Sections of the Indian Panel Code.
- 4.10 It is also notworthy that in case Income and Assets Certificate for EWS Category is issued by the Issuing Authority without due diligence qua the fulfillment of criterion prescribed as cited above and without following the procedure prescribed herein, action under relevant conduct rules i.e. CCS, CCA Rules 1965 may be initiated against such erring issuing authorities.
- 4.11 It is further emphasized that the Income and Assets Certificate for EWS Category may only be issued in accordance with the prescribed criteria by the Govt. of India as per aforesaid DoPT O.M. dated 31.01.2019. However in case it is noticed that a certificate has been obtained by any applicant on the basis of false & Fraudulent facts/information, the Deputy Commissioner of the concerned districts shall cancel such certificate with immediate effect and an intimation thereof shall be sent to the applicant and also to his employer, if it is known to the Deputy Commissioner concerned that the said certificate had been submitted before any employer by such applicant.
- 4.12 The Income and Assets Certificate shall be issued on the basis of Income from all sources pertaining to the financial year prior to the year of filing the application. It implies that for making such applications by an applicant during a financial year he has to provide family, Income details pertaining to previous financial year but details of Immovable Property details shall be as on the date application is being filed before certificate Issuing Authority and it also implies that a Income & Asset Certificate issued shall be valid only for the financial year in which it has been issued. To illustrate by an example:- If an application is filed in the month of May, 2019, the same will be issued on the basis of income for the financial year 2018-19 and the certificate shall remain valid only till 31st March, 2020.
- 4.13 Further for Issuance of Income and Assets Certificate with effect from the financial year 2020-21 and onwards it would be necessary for the applicants to fill up the

details of the Income & Asset Certificates for EWS category obtained in earlier years in the application form, for the period starting from financial year 2019-20 and onwards.

This issue with the prior approval of competent authority.



I would like to invite your kind attention to this Department's D.O. letter of even number dated 21.01.2019 and to inform that vide subsequent OM of even number dated 31.01.2019 detailed instructions were issued regarding reservation in direct recruitment in Civil posts and services in the Government of India for Economically Weaker not covered under Sections(EWS) the reservation SCs/STs/OBCs. This OM is available in the website of this Department at Notifications >> OMS >> 84 Orders Estt.(Reservation) >> Others. A copy of the OM is also enclosed for beady reference.

- 2. The benefit of reservation under the EWS category can be availed upon production of an Income and Asset Certificate issued by the competent authority in the State Government/UT Administration, as mentioned in para 5.1 of the said OM. The authority concerned may kindly be requested to issue the Income and Asset Certificate to the persons eligible for the reservation scheme as EWS in the proforma at Annexure-I attached to the OM.
- 3. The certificate issuing authorities may also kindly be instructed to ensure the veracity of the Income and Asset Certificates so that unscrupulous persons are prevented from jobs meant for EWS by producing a false or fake Income and Asset Certificate. The said authorities should issue these certificates after carefully verifying all the relevant documents and by following due process prescribed by the respective State/UT Governments.
- May I request that suitable instructions relating to issuance of the Income and Asset Certificate and the verification process be issued to all concerned expeditiously.

OFFICE MEMORANDUM

Subject: Reservation for Economically Weaker Sections (EWSs) in direct recruitment in civil posts and services in the Government of India.

In continuation of this Department's Office Memorandum of even number dated 19.01.2019, the following instructions are issued in consultation with Ministry of Social Justice and Empowerment and Department of Legal Affairs regarding reservation for EWSs not covered under the reservation scheme for SCs/STs/OBCs in respect of direct recruitment in civil posts and services in the Government of India.

2. QUANTUM OF RESERVATION

The persons belonging to EWSs who are not covered under the scheme of reservation for SCs, STs and OBCs shall get 10% reservation in direct recruitment in civil posts and services in the Government of India.

3. EXEMPTION FROM RESERVATION:

- 3.1 "Scientific and Technical" posts which satisfy all the following conditions can be exempted from the purview of the reservation orders by the Ministries/Departments:
 - (i) The posts should be in grades above the lowest grade in Group A of the service concerned. 6600
 - (ii) They should be classified as "scientific or technical" in terms of Cabinet Secretariat [OM No. 85/11/CF-61(1) dated 28.12.1961], according to which scientific and technical posts for which qualifications in the natural sciences or exact sciences or applied sciences or in technology are prescribed and the incumbents of which have to use that knowledge in the discharge of their duties.

- (iii) The posts should be 'for conducting research' or 'for organizing, guiding and directing research'.
- 3.2 Orders of the Minister concerned should be obtained before exempting any posts satisfying the above condition from the purview of the scheme of reservation.

4. CRITERIA OF INCOME & ASSETS:

4.1 Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs. 8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq. ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
- 4.2. The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- 4.3 The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

5. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

5.1 The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format as given in Annexure-I shall only be accepted as proof of candidate's claim as belonging to EWS: -

(i) District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/1st Class Stipendary

 (ii) Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate

(iii) Revenue Officer not below the rank of Tehsildar and

- (iv) Sub-Divisional Officer or the area where the candidate and/or his family normally resides.
- 5.2 The Officer who issues the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the respective State/UT.
- 5.3 The crucial date for submitting income and asset certificate by the candidate may be treated as the closing date for receipt of application for the post, except in || each cases where crucial date is fixed otherwise.
- 5.4 The appointing authorities should, in the offer of appointment to the candidates claiming to be belonging to EWS, include the following clause:-

"The appointment is provisional and is subject to the Income and asset certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate."

The appointing authority should verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority.

5.5 Instructions referred to above should be strictly followed so that it may not be possible for an unscrupulous person to secure employment on the basis of a false claim and if any person gets an appointment on the basis of such false claim, her/his services shall be terminated invoking the conditions contained in the offer of appointment.

6. EFFECTING RESERVATION - MAINTENANCE OF ROSTERS:

6.1 Department of Personnel and Training had circulated Office Memorandum No.36012/2/96-Estt(Res) dated July 2, 1997 regarding implementation of post based reservation roster. The general principles for making and operating post

based reservation roster would be as per the principles laid down in the said Office Memorandum.

- 6.2 Every Government establishment shall now recast group-wise post-based reservation roster register for direct recruitment in accordance with format given in **Annexure II, III, IV and V**, as the case may be, for effecting 10% reservation for EWSs interpolating them with the SCs, STs and OBCs. While fixing roster point, if the EWS roster point coincides with the roster points of SCs/STs/OBCs the next available UR roster point has been allotted to the EWSs and also the principle of "squeezing" has been kept in view. While drawing up the rosters, the cadre controlling authorities may similarly "squeeze" the last points of the roster so as to meet prescribed 10% reservation.
- 6.3 Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog.
- 6.4 Persons belonging to EWS selected against the quota for persons with benchmark disabilities/ex-servicemen shall be placed against the roster points earmarked for EWS.

7. ADJUSTMENT AGAINST UNRESERVED VACANCIES:

A person belonging to EWS cannot be denied the right to compete for appointment against an unreserved vacancy. Persons belonging to EWS who are selected on the basis of merit and not on account of reservation are not to be counted towards the quota meant for reservation.

8. FORTNIGHTLY/ANNUAL REPORTS REGARDING REPRESENTATION OF EWS:

The Ministries/Departments shall send single consolidated fortnightly report including their attached/subordinate offices beginning from 15.2.2019 as per format at Annexure-VI.

From 01.01.2020, the Ministries/Departments shall upload data on representation of EWSs in respect of posts/services under the Central Government on the URL i.e. www.rrcps.nic.in as on 1st January of every year. All Ministries/Departments have already been provided respective usercode and password with guidelines for operating the URL.

9. MAINTENANCE OF REGISTER OF COMPLAINTS BY THE GOVERNMENT ESTABLISHMENT:

- 9.1 · Every Government establishment shall appoint a senior officer of the Department as the Grievance Redressal Officer.
- 9.2 Any person aggrieved with any matter relating to discrimination in employment against any EWS may file a complaint with the Grievance Redressal Officer of the respective Government establishment. The name, designation and contact details of the Grievance Redressal Officer may be displayed prominently on the website and in the office of the concerned establishment.

10. LIAISON OFFICER:

Ministries/Departments/Attached and Subordinate Offices shall appoint Liaison Officer to monitor the implementation of reservation for EWSs.

- 11. The above scheme of reservation will be effective in respect of all direct recruitment vacancies to be notified on or after 01.02.2019.
- 12. All the Ministries/Departments are requested to bring the above instructions to the notice of all appointing authorities under their control. In case of any difficulty with regard to implementation of the provisions of this OM, the concerned authorities may consult DOP&T through their administrative Ministry/Department.
