Br./Div.Com/HQ/2010: In exercise of the power conferred by Section 78 of the Registration Act, 1908 (16 of 1908) read with the Government of India, Ministry of Home Affairs, Notifications S.O. 1726, dated the 22<sup>nd</sup> July, 1961 read with Notification No. 41/2/66-Delhi, dated the 7<sup>th</sup> September, 1966 the Lieutenant Governor of the National Capital Territory of Delhi, hereby, authorizes Stock Holding Corporation of India Limited(SHCIL), 2<sup>nd</sup> Floor, 3, Vardhman Trade Centre, DDA Complex, Nehru Place, New Delhi- 110019 to implement the e-Registration project in National Capital Territory of Delhi and to electronically generate the registration fees on behalf of the Government of the National Capital Territory of Delhi.

For generation of e- registration fee receipt, SHCIL will take service charges from the general public as per the slab mentioned below:-

<b>Range of Registration fee (Rs.)</b>	<b>Proposed service charges</b>
Up to 10,000	Rs. 15/- per transaction
10,000 – 1,00,000	Rs. 20/- per transaction
1,00,000 & Above	Rs. 30/- per transaction

The online e- registration fee collection system through SHCIL as well as present system of collection of registration DD/Cash runs concurrently for the first three months & thereafter e-Registration Fee receipt will be mandatory.
