ORDER

The Council of Ministers vide Cabinet Decision No.3338 dated 26.05.2026 has approved to provide ex-gratia compensation of Rs.75,000/- per hectare to farmers in lieu of damages to crop due to heavy rains and water logging of fields during August-September in the year 2025 in the following manner:

- i) Compensation of Rs.75,000/- per hectare may be extended to provide the ex-gratia relief to farmers in lieu of damages to crop due to heavy rains and water logging of fields during August-September in the year 2025 as per sub-division wise details given below:

ii) Eligibility Conditions:

- The farmer claiming ex-gratia must be the recorded owner of the land whose crops has been damaged due to heavy rains during August-September in the year 2025.
- The ex-gratia will not be paid to the land owners who are in the nature of companies or whose land has been vested in Gaon Sabha and the vesting order stands.
- Further, the farm houses, which are in the nature of plots with pucca boundary walls, will also be excluded.

iii) Payment to be released after due verification of beneficiary and through Bank only.
