Public Notice under Section 21 of the RECTLARR Act, 2013

Whereas, earlier, vide notification No. F-ADM/LAC/SE/2023/10/Part-II/135 dated 06.06.2023. the land bearing Khasra No. 8/2/1 (2786.240 Sq. Mtr.), Khasra No. 13/2/1 (3512. 197 Sq. Mtr) of village Nagli Razapur in the Sub Division Defence Colony of District South East Delhi were notified under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) for infrastructure project i.e. construction of 3rd Phase of Elevated Road on Barapulla Nallah from Sarai Kale Khan to Mayur Vihar, New Delhi and published by the Collector in the Part 1 of the NCT of Delhi Gazette, dated 6th June, 2023. (Copy at Annexure-I)

And whereas, the declaration and summary of Rehabilitation and Resettlement scheme has been published under section 19 of RFCTLARR Act 2013 vide Gazette Notification no. 333 dated 1st November, 2023 (copy enclosed as Annexure-II) and also published in newspapers on 3rd November 2023.

As such now, in accordance with section 21 of RFCTLARR Act 2013, notice is being given for intimating to all concerned that the Government intends to take possession of the land mentioned above which is required for "public purpose" and that claims to compensations and rehabilitation and resettlement in above land may be made by all interested by appearing personally or by agent or advocate stating the nature of their respective interests in the land and the amount and particulars of their claims to compensation for such interests, their claims to Rehabilitation and Resettlement along with their objections if any, before the Collector on 02nd December, 2023 at 11.30 AM in the Conference Hall of the office of District Magistrate (South East)
