**Public Notice under Section 21 of the RFCTLARR Act, 2013**

1. Whereas, earlier, vide notification No. F.8/2/16/2015/L&B/LA/10643 dated 28/08/2015 the land specified below was notified under section 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (30 of 2013) for Infrastructure Project i.e. construction of Waste Water Treatment Plant (WWTP) which will treat the Waste Water Generated from the inhabitants of the Tajpur Khurd village and adjoining areas and published by the Collector in the Part 1 of the NCT of Delhi Gazette, dated 28th August, 2015. (Copy at Annexure-I)

2. And whereas, the declaration and summary of Rehabilitation and Resettlement scheme has been published under section 19 of RFCTLARR Act 2013 vide Gazette Notification no. 286 dated 27 July, 2017 (copy enclosed as Annexure-II) and also published in newspapers on 27 August, 2017.

3. And whereas, the further proceedings of acquisition became subject matter of the Writ Petition (C) 11104/2018 titled as Yudhvir Singh & Anr. Vs GNCT of Delhi & Ors. before the Hon'ble High Court of Delhi and the Hon'ble High Court vide its order dated 15/10/2018 directed the parties to maintain status quo with regard to title, nature, possession and construction with respect to the land comprised in Khasra no. 11//11 (4-00), 12/2 (2-10), 19 (4-16), 20 (4-16), 21 (4-12), 22 (4-16), 28 (0-04) and 16//2 (4-12), total admeasuring 30 bighas 06 Biswas, situated in the revenue estate of village Tajpur Khurd, Delhi as given in table in para 1 above.

4. And whereas, the Hon'ble High Court of Delhi in its judgment dated January 24, 2024 in W.P.(C) 11104/2018 and W.P.(C) 320/2018 directed that *both the writ petitions are dismissed. Stay orders in both the writ petitions also stand vacated. No order as to costs. Pending applications, if any, also stand disposed of. A copy of this judgement be placed in other writ petition.*

5. Now therefore, in accordance with section 21 of RFCTLARR Act 2013, notice is being given for intimating to all concerned that the Government intends to take possession of the land mentioned above which is required for "public purpose" and that claims to compensations and rehabilitation and resettlement in above land may be made by all interested by appearing personally or by agent or advocate stating the nature of their respective interests in the land and the amount and particulars of their claims to compensation for such interests, their claims to Rehabilitation and Resettlement along with their objections if any, before the Collector on **12<sup>th</sup> March, 2024 (Tuesday) at 11.30 AM** in the Conference Hall of the office of District Magistrate (South West).


