**ORDER**

**Sub: Transfer/deployment of the Officers/Official/staff consequent upon reorganization of Districts and Sub Division.**

Consequent upon the reorganization of Districts in the GNCT of Delhi, vide Notification No. F.223/SDM-II(HQ)/Land/2025/285 dated 25.12.2025, seamless continuity of administrative functions in the newly created/reorganized 13 Districts (Areas) and 39 Sub-Divisions/Tehsils need to be ensured. Accordingly, the following transfer/postings of officers/officials are hereby ordered with immediate effect.

1. As per the aforementioned reorganisation, erstwhile District Shahdara has been dissolved. Subsequently all the officers/officials and other staff (regular/outsourced) working on the strength of erstwhile district shahdara (except erstwhile Sub-Division Shahdara) will now be placed at the disposal of the reorganised District - Central North.
