A notification under section 4 of the Land Acquisition Act, 1894 was issued vide notification No. F.7(35)/95-L&B/LA/II/5430 dated 12.6.1997 for acquisition of an area measuring 41 Bigha only in Village Chandrawali. This land was required to be acquired by the Government at the public expense for public purpose namely for Mass Rapid Transport System, Delhi.

In pursuance of the above notification under section 4, it has been cleared that the provisions of section 5 (A) shall not apply. Notification U/s 4 was followed by notification under section 6 of even number F.7(35)/84/L&B/LA/II/ 9064 dated 28.7.1997 and under section 17(1) of even No. F.7(35)/95/L&B/LA/II/9064 dated 28.7.1997. Possession has however not been taken pursuant to Notification U/s 17(1).

Notices under section 9 & 10 of L.A. Act, 1894 were issued to the persons interested which will be described under appropriate heading.

#### MEASUREMENT & AREA. :

Necessary demarcation was carried out on the spot in the presence of field staff from M.R.T.S., Delhi, Land & Building Department and L.A.C. (Shahdara). During demarcation it revealed that the total area measures 39-10 (Bigha-Biswa) instead of 41 Bigha as shown in notification under section 4 & 6. This mistake occurred due to the fact that Kh. No. 447 was shown measuring 13 Bigha 16 Biswa in Notification U/s 4 & 6 but in actual as per our revenue record i.e. field book, the area of this Khasra No. is 12-06 (Bigha-Biswa) instead of 13-16 (Bigha-Biswa). So, there is a difference of 1 Bigha 10 Biswa.

Hence, the total area may be considered as 39-10 (Bigha-Biswa) instead of 41 Bigha and area of Khasra No. 447 may be considered as 12-06 (Bigha-Biswa) instead of 13-16 (Bigha-Biswa).



STRUCTURE (Rooms & Shops) with valuation :

This is a thickly built up area covered by residential small houses and shops, the details and valuation assessed by PWD has already been mentioned under the title "CLAIMS & EVIDENCE".

**MARKET VALUE :**

None of the interested persons have submitted any sale deed in support of his claim for compensation of land. A reference was also sent to Sub-Registrar IV, Seelampur, Delhi to ascertain whether any sale deed has been executed for any Khasra No. mentioned above or part thereof. He has informed that no sale deed has been executed for Khasra Nos. mentioned above or part thereof subsequent to Notification U/s 4 till date. Thus, no indicative market price of land under acquisition has been submitted before me.

Survey has revealed that Makki Sarai is having abadi since long i.e. more than 25 years. A confirmation was sought from MCD regarding status of land/area under acquisition. As per MCD record, land under acquisition is an urbanised colony. Accordingly, rates of agricultural land are not applicable and hence I have no alternative but consider the latest rates fixed and published by Ministry of Urban Development for urbanised properties for determination of market value of land under acquisition.

There is a Government Order No.J.22011/4/95-LD dated 16.4.1999 of Ministry of Urban Development on the question of fixation of market price of land in different areas of Delhi/New Delhi w.e.f. 1.4.1996. For Zone 5 (East Delhi), the land price have been fixed as under :-

The land under acquisition is in proximity and adjoins Jheel Khuranja and Geeta Colony and the area is residential having some shops also. The area is not notified as Commercial by the Municipal Corporation of Delhi.

Considering the above facts, I determine the market value of the land under acquisition @ Rs. 2805/- per sq. mts. In addition to the market value, the interested persons will be entitled to other benefits under provisions of the Act.

**SOLATIUM :**

30% solatium will be given to the interest persons due to compulsory nature of acquisition under section 23 (2) of the L.A. Act, 1894.

**ADDITIONAL SUM U/S 23 (1) :**

12% of the market value from the Date of Notification to date of award will be given.

**APPORTIONMENT :**

Compensation of the acquired land will be given as per latest entries in the revenue record. In case of dispute, the matter will be referred to the Court of Addl. Distt. & Sessions Judge, under section 30-31 of the Land Acquisition Act, 1894.

**LAND REVENUE :**

The land under acquisition is assessed for sum of Rs. ---NIL--- as land revenue. Hence, the same will be deducted from the rent roll of the village with effect from the date of taking over the physical possession of the said land.
