This supplementary award is drawn up for acquisition of 210 bighas situated in village Mandoli Fazalpur. This area was left out of original award No. 2179 as it was built up and the instruction regarding to the acquisition of said built up area were to be sought from the Land & Building Department, Delhi Administration, Delhi. The instructions have now been received from Secretary Land & Building to use the acquisition proceedings for the same. This land was acquired u/s 4 of the Land Acquisition Act, 1894 vide notification No. 15(iii)/59-LSG dated 13.11.1959 and u/s 6 vide notification No. 4(19)/65-L & H dated 18.3.66.

Asstt. Engineer (Valuation) CEWD, Delhi Administration was asked to evaluate structures of the said Khasra Nos but still no valuation report received in this office. The High Court has stayed dis-possession over Khasra No.1254/928/512/1(24 bighas 6 biswas) vide order dated 27.5.68 in civil writ No.378/68 Shri Uggar Sain Kashyap Vs. Union of India and others. In view of this stay order and structure existing over the land mentioned above, it will not be possible to take possession of the land until the structures are evaluated and stay is vacated. It is therefore proposed to exclude 16 bighas 4 biswas of land from present acquisition. This area will be acquired under a supplementary

In evidence some of the claimants ^{have} produced copies of the sale deeds to prove that they are owners of the plots under acquisition. The sale deeds pertain to transactions which had taken place during years 1953, 1955, 1956, 1958 & 1959. The average rate ranges from 0.75 per sq.yd. to ^{2.75} Rs.275 per sq.yd. All these sale deeds are in respect of small plots. It is a general trend that smaller plots fetch higher price. Hence they are not relevant for the purpose of assessing market value of the land under present acquisition.

MARKET VALUE

Part of the area under present notification u/s 6 was acquired under Award No.2179 and the factors which led to the assessment of market value for the land have been discussed in detail in Award No.2179. The land acquired under Award No.2179 was divided into three blocks 'A', 'B' & 'C' according to the productivity and situation of the land. The Chahi land which is irrigated and capable of producing two yields was classified in block 'A' and the land which is banjar ^{and} less productive was classified in block 'B'. The land which is most inferior and is low lying was classified into block 'C'. The Land Acquisition Collector awarded Rs.1500/- per bigha for land in block 'A', Rs.1000/- per bigha for land in block 'B' and Rs.700/- for land in block 'C'. The land under present acquisition falls under block 'B' on the considerations mentioned in award No.2179 and is therefore assessed to Rs. 1000/- per bigha.

There is a pucca road in Khasra No. detailed under the head "True & correct Area" over 6 bighas 4 biswas which is dedicated to public use. No compensation has therefore been assessed.

OTHER COMPENSATION

Structures:

From spot inquiry N.T.(LA) has reported a number of structures on several khasra numbers under acquisition. There is no entry in revenue record prior to the date of notification u/s 4. No evidence has been produced to show that these structures existed prior to 13.11.1959. No compensation has, therefore, been assessed.

In Award No.2179 land in Khasra Nos. 99/153, 19, 132, 154 was acquired but 17 structures existing thereon prior to 13.11.59 were not assessed as valuation report from Asstt. Engineer C.P.W.D. Delhi Administration was not received. Now Asstt. Engineer(Valuation) has reported vide letter No.A.E.Vali/I/112/69 dated 2.7.69 valuation of the structures as given below:-

INTEREST.

According to the provisions of the L.A.(Amendment & Validation) Act, 1967, simple interest at the rate of 6% p.a. is allowed on the market value of the land from the date of expiry i.e. 12.11.62 as the final declaration u/s 6 of the L.A.Act was made after three years from the date of publication of the notification u/s 4 of the L.A.Act.

There is a stay order against dispossession regarding Khasra numbers 425 min, 436, 437, 438, 446, 452, 454, 1283/456, 460, 461, 435, 1257/510, 463, 464, 466, 471, 472, 473, 477, 478, 484, 505, 506, 508, 509 total area 20120 sq. yds.(20 bighas 1 biswas) from the High Court of Delhi vide order dated 7.8.1967.
