These are the proceedings for the acquisition of land measuring 1 Bigha 16 Biswas bearing Khasra Nos. 2322/39 of village Karkar-dooma. The land was notified u/s. 4 of the Land Acquisition Act vide notification No. F.15(III)/59-LSG dated 13.11.59 for a public purpose, namely the Panned Development of Delhi. The substance of the said notification was given due publicity and objections were invited from the interested persons. The objections were duly heard and a report u/s. 5-A of the Land Acquisition Act was sent along with the objections in original to the Land & Building Department Delhi Administration. After that a final declaration u/s. 6 of the Land Acquisition Act was issued by the Delhi Admn. vide notification No. F.15(207)/L&B dated 13.3.64. Notices u/s. 9 & 10 of the Land Acquisition Act were issued to all the interested persons. The claims filed by them are discussed herewith under the heading 'Claims & Evidence'.

MEASUREMENT & TRUE AREA:-

The Land Acquisition field staff carried out the necessary measurement of the land at the site and its verification was also made from the revenue record of the village. The total area measuring 1 Bigha 16 Biswas was found to be correct and true area. The details of the area under present acquisition are given below:-

All above awards relate to the notification of dt. 13.11.59. The rate of compensation has been enhanced by the court in most of these awards to Rs. 6000/- per bigha. Since the land now being acquired relates to the same notification and is of the same quality as the one for which rate has been enhanced, I assess

the same at the rate of Rs.6000/- per Bigha for the land now under acquisition.

SOLATUM :-

30% solatium will be paid on the market value assessed of the land under acquisition.

ADDITION AMOUNT U/s. 23(1-A).

The additional amount u/s. 23(1-A) of the land acquisition Act (amended) will be paid over and above the total market value @ 12% p.a. w.e.f. 13.11.59 (date of notification u/s.4 of the Land Acquisition Act) till the date of Award i.e. 27.9.86.

INTEREST UNDER SECTION 4(3) :

The interest under section 4(3) under the Land Acquisition Act will be paid from 13.11.62 to 22.9.86 for a period of 23 Yrs. 314 days).

LAND REVENUE:-

An amount of Rs.0-38 Paise on land under acquisition is assessed as land revenue which will be deducted from the rent roll of the village w.e.f. the date of taking over the physical possession.

APPORTIONMENT:-

The compensation will be paid to the rightful owners on the basis of latest entries in the revenue record. In case of any dispute between the parties which is not settled, that matter will be referred to the Court of A.D.J. Delhi U/s. 30-31 of the Land Acquisition Act.
