AWARD NO. : 30/84-85 (Supplementary)
Village : Chandrawali alias Shahdara
Nature of Acquisition: Permanent
Purpose of Acquisition: Park site in Sri Nagar Colony.

INTRODUCTION:

The land measuring 19 Biswas situated in village Chandrawali alias Shahdara was notified vide notification Nos.F.8 (56)/76-L&B (1) (2) (3) dt. 7/2/84 u/s 4, 6 & 17 respectively. This land was acquired vide award No. 30/84-85 announced on 24/1/85. It was mentioned in award No. 30/84-85 that 'As per the latest amended L.A. Act 1984 supplementary award will be announced later on. Hence it is the supplementary award of Award No. 30/84-85.

ADDITIONAL COMPENSATION U/S 23(1A) OF L.A. ACT 1984:

An amount of Rs. 75280/- was assessed as market value of land measuring 19 Biswas and physical possession of land measuring 17 Biswas only was taken over on 15/3/84. Therefore, 12% P.A. w.e.f. 7/2/84 i.e. date of notification u/s 4 upto 15/3/84 is payable as per section 23(1A) of L.A. (Amendment) Act 1984.

SOLATUM:

15% as solatium on the market value is payable as per section 23(2b) of L.A. (Amendment) Act 1984.

INTEREST:

6% P.A. Interest u/s 34 of L.A. Act 1894 has already been awarded. Now 3% P.A. more interest u/s 34(a) of L.A. (Amendment) Act 1984 is payable on the compensation of 17 Biswa only.

B. Interest u/s 34 of L.A. Act 1894 @ 6% on Rs. 78200 from 13/8/84 to 24/1/85 is also payable.
