## INTRODUCTORY :

These are the Supplementary proceedings of Award No. 49-C/70-71 announced on 22/12/1982 in respect of Village Mandawli Fazalour, Delhi. After the announcement of the Award, the Land Acquisition Act 1894 has been amended and the Amendment Act came into force with effect from 24th September. 1984.

Under the Amended Act (68 of 1984), the provisions of Sub-section 2 of section 23 have been amended by clause (b) of Section 15 of the Amended Act and which prevides solatium at 30%. A new sub-section (1-A) of Section 23 of the Principal Act, have also been inserted by clause (a) of section 15 of the Amended Act which provides 12 per cent additional compensation on the market value from the date of publication of notification under section 4 of the Land Acquisition Act till the date of the Award of the Collector.

As per prevision of Section 30 of the Amended Act of 1984 the prevision of Sub-section (1-A) of Section 23 of the Principal Act as inserted by clause (a) of Section 15 of the Amended Act and sub-section(2) of Section 23 as amended by clause (b) of Section 15 shall also apply in every proceedings for acquisition of any land under the Principal Act bending on the 30th day of Abril, 1982( the date of introduction of Land Acquisition ( Amendment ) Aux Bill 1982, in the House of People) in which no award has been made by the Collector before that date.

Keeping in view of the previsions of amended Act, the interested persons/bhumidhars of Award No. 49-C/70-71 announced en 22-12-1982 are also entitled for payment of solatium at 30% on the market value and 12% as additional compensation with effect from 13-11-1959, the date of publication of the notification under sedtion 4(i) of the Land Acquisition Act till 22/12/1982, the date of announcement of award.
