

Award No. 1 - 79-A/1/72-73 (Supp.)

SUPPLEMENTARY AWARD OF 79-A/1/72-73

VILLAGE : SAMASPUR JAGR.
NATURE OF ACQUISITION : PERMANENT
PURPOSE OF ACQUISITION : PLANNED DEVELOPMENT OF DELHI.

These are the supplementary proceedings of Award No. 79-A/1/72-73 announced on 30.4.83. After the announcement of the above award, the Land Acquisition Act 1894 has been amended and the amendment Act came into force w.e.f. 24th Sept., 1984.

Under the amended Act (68 of 1984), the provision of sub-section 2 of section 23 has been amended by clause (b) of section 15 of the Amended Act, in which provided solatium at 30%. A new sub-section (1-A) of section 23 of the Principal Act has also been inserted by clause (a) of section 15 of the Amended Act, which provides 12% additional amount on the market value w.e.f. the date of Notification u/s 4 of the L.A. Act till the date of the Award of the Collector.

As per provision of section 30 of the Amended Act of 1984 the provision of sub section (1-A) of section 23 of the Principal Act as inserted by clause (a) of section 15 of the Amended Act and sub section (2) of section 23 as amended by clause (b) of section 15 shall also apply in every proceedings for acquisition of any land under the Principal Act pending on the 30th day of April, 1982 (the date of introduction of Land Acquisition (Amendment) Bill 1982 in the House of People); in which no award has been made by the Collector before that date.

Keeping in view of the provisions of Amended Act 1984, the interested persons/Bhoomidhars in Award No. 79-A/1/72-73 announced on 30.4.83 are also entitled to get the payment of solatium @ Rs. 30% on the market value and 12% as Addl. Amount w.e.f. 13.11.59 to 30.4.83 (the date of Award)

As per above discussion, the amount as detailed below is allowed to the interested persons of Award No. 79-A/1/72-73, the amount already assessed under this award will be deducted.
