The land was notified w/s 4 of the Land Acquisition Act vide notification No. F. 15(111)/59 LSG dated 13.11.59 for a public purpose, namely, the Planned Development of Delhi. The substance of the said notification was given due publicity and objection were inited from the interested persons. The objections were duly heard and a report w/s 5-A of the Land Acquisition Act was sent alongwith the objections in original to the and & Buildig Department Delhi Administration After that a final declaration w/s 6 of the Land Acquisition Act was issued by the Belhi Admn. vide notification No. F. 4(19)/65-L&H dated 18.3.66. Notices U/s 9 & 10 of the Land Acquisition Act were issued to all the interested persons. The claims filed by them are discussed herewith under the heading Claims & Evidence. All the above awards relate to the notification date of 13.11.59. In case of award No.2179 the court has enhanced the rate of compensation to Rs. 4000/- per bigha. Since the present land relates to the same notification and it is considered to the one acquired, I assess the same rate i.e Rs. 4000/- per bigha as the market value of the land being acquired under this award.

# ADER TIONAL AMOUNT U/s 23 (1-A):

The add onal amount U/s 23(1-A) of the land acquisition Act (Amended will be paid over and above the total market value @ 12% p.a. w.e.f. 13.11.59( date of notification U/s 4 of the Land Acquisition Act) till the date of Award i.e 18.9.86.

INTEREST UNDER SECTION 4(3)

The Interest under section 4(3) under the L.A. Act will be paid from 13.11.62 to 18.9.86 for a period of 23 years-310 days.

An amount of Rs. 2-53 paise on land under acquisition is LAND REVENUE: assessed as land revenue which will be deducted from the rent roll of the village w.e.f. the date of taking over the phy sical possessin.

The compensation will be paid to the rightful owners on the APPORTIONMENT basis of latest entries in the revenue record. In case dispute between the parties which is not settled, the matter will be referred to the court of ADJ Delhi Ws, 30-31 of the L.A. Act.
