INTRODUCTION:

These are the supplementary proceedings of Award No. 70/82-83 announced on 23.2.83 for the land measuring 9 Bighas. After the announcement of above award the land acquisition Act 189 has been amended and the amendment came into force w.e.f. 24.9.84. Under the Amendment Act (68 of 1984) the provisions of sub section 2 of section 23 have been amended by clause (b) of section 15 of the Amended Act and which provides solatium @ 30% on the market value. A new sub section (1-A) of section 23 of the principal Act have also been inserted by clause (a) of section 15 of the amended Act ~~till~~ which provides 12% addl. compensation on the market value from the date of publication of notification u/s 4 of the L.A. Act till the date of award of the collector or date of taking possession whichever is earlier. As per provisions of section 30 of the L.A. (Amendment) Act of 1984 the provisions of section 23(LA) of the principal Act as inserted by clause (a) of section 15 of the Amended Act 1984 and sub section (2) of section 23 as amended by clause (b) of section 15 shall also apply in every proceeding for acquisition of any land under principal Act pending on 30.4.83 (the date of introduction of Land Acquisition Amendment Bill 1983 in the House of People) in which no award has been made by the Collector before that date.

Keeping in view the provisions of the Amended Act, interested persons/Bhumidars of award No. 70/82-83 announced on 23.2.83 are also entitled for payment of solatium @ 30% on the market value and 12% P.A. as additional compensation w.e.f. 22.3.78 i.e. date of notification u/s 4 of the L.A. Act upto 23.2.83 i.e. date of announcement of Award No. 70/82-83.

As per above discussion the following amount is also allowed to the interested persons of Award No. 70/82-83 and the amount shall be apportioned as per original award No. 70/82-83.
