These are proceedings for determination of compensation under section 11 of the L.A. Act. The land under acquisition is situated in village Keshopur and was notified u/s 4 of the L.A. Act by notification No.F.15(III)/59-LSD dated 13.11.59 for public purpose namely for the Construction of Outer Ring Road No.26. After considering objections u/s 5-A, the Delhi Administration issued a declaration u/s 6 of the L.A. Act for an area mg.37 bighas b.i.s. vide notification No.F.4(29)/64-LSD dated 31st July, 1968. Pursuance of the forest side notification notices u/s 9 and 10 of the L.A. Act were issued to all the persons interested in the land under acquisition. The claims filed by the claimants are discussed hereafter under the heading 'Compensation claims.'

MEASUREMENT & CONDUCT AREA

The land under acquisition was measured on the spot by the acquisition field staff. The area available at the spot is 37 big. 6 bis instead of 37 big. 8 bis. The difference of 2 biswas due to tukimes. Out of the land mg.37 bighas 6 bis. which is under the alignment of the Road No. 26, land mg.13 big.6 bis. has already been acquired by Award No. 807 and 1845 of village Keshopur. The rest Kh.Nos. will be only took transferred. The details of the acquired land is given as under:-

Has produced a copy of sale deed No. 3330 dated 19.11.68 bearing Khasra No. 13/18, area measuring 100 sq. yds. for a sum of Rs. 700/- which is under acquisition. Has also produced House Tax Receipt No. 399030 dated 7.8.75.

11. SRI BIL KUMAR NOMINEE OF SRI. RAM LOKHAT:

Has produced a copy of General Power of Attorney in respect of Khasra No. 13/18 measuring 90 sq. yds.

12. SRI KIRPA RAM:

Has produced a copy of sale deed No. 11866 dated 8.10.78 in which Khasra No. 13/13 measuring 100 sq. yds. was purchased in which Khasra No. 13/13 measuring 100 sq. yds. was purchased in this scheme. Has also submitted a copy of House Tax dated 24.10.78.

MARKET VALUE:!

The market value of the land under acquisition has to be assessed after keeping in view the advantages and potentialities attached to the land. The other important factor as contemplated under Section 3 of the Land Acquisition Act which guides the Land Acquisition Collector in assessing the amount of the compensation is the market value of the land at the date of publication of notification under section 4. Transaction of transfer of property effected around the time of publication of such notification can obviously prove the best guide for deciding such market value. Previous awards of the village and judicial decisions can also afford guidance in determining the market value of the land.

Some of the interested persons have filed copies of sale mentioned under the head 'Documentary Evidence' in support of their claims. These sale deeds are of small plots purchased for residential purposes. It is a general principle that small plots of land meant for residential purposes fetch more value than the bulk of land meant for agricultural purposes. Delhi Land Reforms Act is applicable on the land under acquisition and can not be used for a purpose other than agriculture, horticulture etc. These sale deeds, therefore, can not give any guidance in determining the market value of the land and I discard the same.

It has been seen from the record that land measuring 3 bighas 16 biswa of village Keshopur was acquired by the Land Acquisition Collector vide xx award No. 1845. The land was classified four blocks namely: A, B, C & D. The Land Acquisition Collector awarded Rs. 1000/-, Rs. 800/- Rs. 600/- Rs. 400/- per bigha kham for block A, B, C & D respectively. The date of notification u/s 4 of the Land Acquisition Act this award was 13.11.59. The ADJ in a reference u/s 18 of the Land Acquisition Act in cases No. 404/66, 406/69, 391/66, 395/66, 393/66 linking block B & C to block A enhanced the compensation to Rs. 3500/- per bigha kham. Following these judgements of the ADJ the Land Acquisition Collector allowed the same rate of Rs. 3500/- per bigha kham in award 47/72-73 of village Keshopur. The date of material notification in this case was also 13.11.59. Land under present acquisition is located in the near vicinity of land acquired vide award 1845 & 47/72-73. The date of notification of the land under acquisition is also 13.11.59 i.e. similar to award No. 1845 and 47/72-73. Under the circumstances the decision of the ADJ referred above and allowed in award No. 47/72-73 is a proper and best evidence for assessing the market value of the land under consideration. Accordingly I feel it shall be fair and just if the market value of the land under acquisition is determined at Rs. 3500/- per bigha kham. I determine accordingly.

STRUCTURES:!

The site inspection of the land under acquisition revealed that there are number of built up houses. As per record shown by the owners of the houses the following structures were in existence on the land under acquisition on the date of notification u/s 4 of Land Acquisition Act 13.11.59.

The structure existed on the land under acquisition referred above had been got valued from SW-III(PWD) Delhi Administration, Delhi and he has furnished the valuation statement of the structures. has determined Rs. 323/- in respect of structures existed on Khasra No. 13/18 and Rs. 6653/- in respect of structures existed on Khasra No.

I have gone through the valuation report and totally agree with the value made by SW-III(PWD) Delhi Administration, Delhi and award the same.

All other structures were existed on the land under acquisition after 13.11.59 which is the material date of notification in the instant case. Since these structures came into existence after 13.11.59, no compensation shall be paid to the owner of these structures. However they are at liberty to remove their structures at their own cost.

WELLS & TILLS:

There is no well or tree on the land under acquisition.

RELIGIOUS PLACES:

There is no religious place except a nishan of Guru Nanak which was constructed by the Gurdwara Sangat Singh Sabha Bhat Birkha on Khasra No. 13/18 after the issue of date of notification u/s 4 of the Land Acquisition Act. Accordingly no compensation is paid being a construction after 13.11.59.

SOLATIUM:

15% solatium is payable as per provisions of the Land Acquisition Act.

INTEREST:

The land under acquisition was notified u/s 4 on 13.11.59. According to the Land Acquisition(Amendment & Validation)Act, 1967 the interested party is entitled to interest at the rate of 6% from 13.11.59 to the date of announcement of the award.

APPOINTMENT:

The compensation will be paid in accordance with entries in the latest revenue records. Khasra Nos. 13/18, 3/2, 4/2, 7/1, 8/1, 23/1, 13/2, 14/1, 5/1, 17/1, 18/2 and 6/25/1/1 are belonging to..... Contd

Gram Sabha Keshopur but some person have produced sale deeds which show that they have purchased the land in shape of plots and out of these above said Khasra Nos. and also claimed compensation for the entire Gaon Sabha Land. Compensation of those Khasra Nos. be held as disputed and will be sent to ADJ for disposal. Some persons have sold the land in the shape of plots but mutation in favour of purchasers have not been sanctioned in the revenue record. However compensation of these numbers is to be held disputed.

LAND REVENUE:

The land under acquisition is assessed to Rs. 1.13P as land revenue which will be deducted from the Rent Roll of the village from the date of possession is taken over.
