Name of village: Raja Pur Kalan.  
Nature of acquisition: Permanent.  
Purpose of acquisition: Remodelling of Bawana Escape from R.D. 60250 to 54250 and R.D. 47650 to 41630.

These are proceedings for the determination of compensation u/s 11 of the L.A. Act, 1894. Land measuring 1 bigha 13 bis. situated in village Raja Pur Kalan was notified u/s 4, 6 and 17(1) of the L.A. Act, 1894, vide notification Nos. F.15(95)/67-I&H(1), F.15(95)/67-I&H(ii) and F.15(95)/67-I&H(iii), dated 11.2.70 respectively, for acquisition at public expense for a public purpose namely for Bawana Escape from R.D. 60250 to 54250 and R.D. 47650 to 41630. Notices u/s 9 & 10 of the Land Acquisition Act, were issued to all the persons interested. The claims and objection filed by the persons interested are discussed under the head 'Claims'.

MEASUREMENT.

The area as given in the declaration u/s 6 is one Bigha 13 biswas which was found correct according to the revenue record and measurement made by the field staff on the spot.

The above classification of land has been obtained from the revenue record as per entries of Khasra Girdawri at the time of notification u/s 4. The land owners have not raised any objection regarding the measurement and classification of land in their claims u/s 9 and 10 of the L.A. Act.

POSSESSION:

Ruina

The possession of the land measuring 1 big. 13 bis. was taken over and handed over to the department concerned on 4.12.70.

MARKET VALUE:

Kumar

The area of this village is governed under the Delhi Land Reforms Act, 1954, and cannot be used for purposes other than agriculture with but the prior sanction of prescribed authority. In order to determine a fair and reasonable market value for the land now under acquisition, sale transactions and the awards drawn up in this village should have been considered. However, whether there is any sale transaction during 5 years prior to the date of the notification u/s 4, nor any land was acquired by the government in this village.

In the absence of any relevant sale deed in the village there is no other alternative except to seek recourse to sale transactions in the adjoining villages which is also a proper method of evaluating

the market value of the land under acquisition. Village Holambi Kalan is adjacent to village Rajapur Kalan and as such the sale transactions in the former village can be referred to in arriving at the market value. A perusal of the record-of-rights reveals that the following sale transactions took place nearest to the material date:-

Transaction at S.No.2 is not a proper example to evaluate the market value of the land since the land involved in this transaction is small in size and just contiguous to the village abadi. Such a transaction cannot reflect the market value of the land under acquisition which is agricultural in character. Likewise transaction at S.No.4 is not dependable as the local enquiries made by the field staff reveal that the vendee paid a fancy price to obtain the land for getting direct access to his grow. It is no gain-saying that in such a transaction the vendee is always guided by certain considerations, and, therefore, it is never a genuine bargain between a willing buyer and a willing purchaser. Transactions at S.No.1 & 3 can, therefore, only be applied in the assessment of the market value. Out of the two transaction No.3 is a better example since the date of the execution of the sale transaction is nearer to the material date and that ka piece of the land under acquisition forms parts of the instant sale transaction. But there is a time gap of a little more than two years between this sale transaction and the material date involved in the instant case of acquisition. Allowing 6% rise due to general rise in prices I fix the market value of the land under acquisition @ Rs.1125/- per bigha.

SOLATIUM:

At the rate of 15% for compulsory acquisition will be payable to the interested persons.

INTEREST:

The interested persons are entitled to get the interest at the rate of 6% per annum on the awarded amount from the date of possession i.e. 4.12.70 to the date of announcement of the award.

LAND REVENUE DEDUCTION:

The land in question is assessed to a sum of Rs.1.29 paise as land revenue. The amount will be deducted from the Khalsa rent roll w.e.f. the date of taking over possession i.e. 4.12.70.

APPORTIONMENTS:

The interested persons shall be paid compensation according to the latest entries in the revenue record of the land. In case of any dispute the payment will be made after any amicable settlement between the parties concerned, failing with the matter shall be referred to the A.D.J. for adjudication. Subject to the above remarks the award is summarised as here under:-

NOTIFICATION

No.T.15(95)/67-L&H(i):- Whereas it appears to the Lt.Governor, Delhi that land is likely to be required to be taken by Government at the public expense for a public purpose, namely, for Bawana Escape from R.D.50250 to 54250 and P.D.47650 to 41630, it is hereby notified that the land in the locality described below is likely to be acquired for the above purpose.

This notification is made under the provisions of section 4 of the Land Acquisition Act, 1924, to all whom it may concern.

In exercise of the powers conferred by the aforesaid section, the Lt.Governor is pleased to authorise the officers for the time being engaged in the undertaking with their servants and workmen to enter upon and survey any land in the locality, and do all other acts required or permitted by that section.

The Lt.Governor being of the opinion that provisions of sub-section (i) of section 17 of the said Act are applicable to this land, is further pleased under sub-section (4) of the said section, to direct that the provisions of section 5-A shall not apply.
