While drawing up award for the land of village Chowkahandi and notified u/s 6 vide notification No.F.4(24)/64-L&H dated 18.10.65 it was noticed by the Land Acquisition Collector (P) that 2 bighas 4 biswas were acquired twice, first in offer No.715 and secondly in offer No.870, followed by Supplementary offer Nos. 715-A and 870-A respectively. The compensation paid in excess is, therefore, recoverable from the owners whose land is being acquired as per the said notification. The details are as under:-
