Act, 1894 made vide was Notification F.8(19)/2006/L&B/LA/ 10237 dated 17.10.2007 in r/o an area measuring 12 Bigha 08 Biswa of Village Mirpur Turk, 02 Bigha 17 Biswa of Village Mustafabad and 3 Bigha 19 Biswa of Village The substance of the said notification was given due publicity in the leading news papers & by pasting at the various points in the notified area. Notices u/s 9(1) & 10(1) of the Land Acquisition Act, 1894 were issued on 17.4.08, inviting claims from the owners/occupants/interested person. The claims from the interested persons were received which are discussed in detail under the headings "Claims & Evidences".



#### Market Value:-

#### Land:

The land under acquisition is agricultural land, hence the market value/price of the land under acquisition has been calculated on the basis of price fixed by Govt. of NCT Delhi.

The notification U/s 4 of the land under acquisition was issued on 29.01.2007 i.e. earlier to the revised rates(dated 24.01.08) notified

Neuen 1 1913/09 by the Land & Building Deptt. Thus the market value of the land has been calculated in accordance with the Govt of NCT Delhi order No.F.9(20)/80/L&B/LA/6720, dated 30.08.2005. The market value of the land under acquisition is Rs.17,58,400/- per acre which is equivalent to Rs.434.52 per sq. meter. (@ 1 acre = 4046.72 sq.meter)

#### Structures;

There are built up properties & super structures in the area but all these structures are unauthorized, and illegal. The valuation of unauthorized structure are not to be paid by the government.

## Handing over taking over possession:-

The owners/occupant/interested persons in r/o the land under acquisition will be given sufficient time as per provisions of Land Acquisition Act, 1894 to vacate the land & to remove their moveable properties from the buildings & hand over the vacant possession to LAC.

Subsequently the physical possession of the land including built up property in toto acquisition will be handed over to M.C.D. through staff of L & B Deptt in the presence of the staff of DDA.

#### Solatium:-

On the market value so determined, the owners/interested persons are entitled to get 30% extra compensation as solutium as per the section 23(2) of the Land Acquisition Act, 1894.

#### Additional Amount:-

The interested persons are also entitled to have an additional benefit @ 12% per annum on the market value of the land U/s 23 (1-A) of the Land Acquisition Act from the date of notification U/s 4 till the date of Award.
