INTRODUCTION:

Delhi administration issued notification No.F.16(245)/
60-LxG/LxH dated 24.10.1961 u/s-4 of the Land Acquisition
Act, 1894, for acquisition of about 16000 acres of land in
several villages in Delhi at the public expense for a public
purpose namely, for the Planned Development of Delhi, and
village Badli is one of the villages where land is covered under
the said notification. Separate declarations u/s-6 of the
said Act are being issued by the Delhi administration as and
when necessity arises for acquisition of land. A declaration
u/s-6 of the said Act was issued vide notification No.F.4(5)/
63-LxH(1) dated 6.12.66 for acquisition of land measuring
5897 bighas 18 biswas for the purpose mentioned above. Notices
in pursuance of the declaration u/s-6 of the said Act were
issued to the persons interested to file their claims.
However, at present land measuring 0-19 biswas is being
acquired. In response to the notices issued u/s 9 & 10 of
the Act, the claimants had submitted their claims which were
discussed under the heading 'Claims in award No.40/1973-74.

MEASUREMENT

The area under acquisition as given in the declaration
u/s-3 is 5897 bighas 18 biswas but at present only 0-19 biswas
is being acquired as per directions from the Secretary, Land
& Building, Delhi Administration, Vikas Bhawan, New Delhi,
vide his letter No.F.11(31)/72-Lx3 dated 20.6.74. The remaining
area will be acquired by drawing a supplementary award
as and when required by the Government.

Classification of land.

POSSESSION

The possession of the area now being acquired has not so far been taken by the department concerned.

MARKET VALUE

The area of this village is governed by the provisions of Delhi Land Reforms Act, 1954. Therefore, the land in this village cannot be used for purposes other than agriculture.

The claims of the interested persons have already been discussed in award No.40/1973-74 and there is no need

to discuss them again. The land under acquisition is divided into following blocks:

BLOCK I

Land of good even level is included in this block comprising the following khasra Nos. 5/2/1, 6/1/2/1, 6/1/2/1, 6/2/1/2, 7/2/2/1, 14/1/2 of Rect. No. 68 and 148/4.

BLOCK II

Land having a depression varying from 3 to 5 feet from which earth had been taken out for making brick is included in this block. The following khasra numbers are included in it:

1/2/2, 2/1/2 of Rect. No. 69.

On the basis of award No. 40/1973-74, I assess the market value of the land of Blocks I & II at Rs. 1250/- & Rs. 800/- per bigha respectively.

TREES, WALLS & STRUCTURES

There is no tree, wall or structure on the land under acquisition.

APPORTIONMENT

The persons interested shall be paid compensation according to the latest entries in the revenue record of the land under acquisition. In case of any dispute the payment shall be made after amicable settlement between the parties concerned failing which the matter shall be referred to the competent court for adjudication.

SCH. D

The interested persons will be entitled to have 15% solatium on the compensation awarded to them for compulsory acquisition.

EXEMPTION FROM LAND REVENUE DEDUCTION

Wholesome amount of reduction from the land revenue dues on account of land acquired works to Rs. 0=28/-

There will be deduction of this amount from the Khatuuni of the village w.e.f. the date of taking over the possession.
Interest.

The possession of the land now under acquisition has not so far been taken by the Collector. However, according to the provisions of the Land Acquisition(Amendment & Validation) Act, 1967, simple interest @ 6% per annum is to be allowed on the market value of the land if the declaration u/s-6 of the said Act, has not been made within three years from the date of publication of notification u/s-4 of the Act. In this case the notification u/s-4 was published in the Gazette on 25.10.61 and the declaration u/s-6 on 5.12.66. So, the persons interested will get interest on the market value of the land (excluding 15% solatium) 6% per annum from 25.10.64 to 30.3.75.

The awarded land will vest in the Government absolutely free from all encumbrances w.e.f. taking over possession.

Subject to the above remarks, the award is summarised as hereunder:

1. Compensation for land measuring 3-11 biswas of block No.I @ Rs.1250/- per bigha.	=	Rs.3975.00
2. Compensation for land measuring 3-05 biswas of block No.II @ Rs.800/- per bigha.	=	Rs.2400.00
3. 15% for compulsory acquisition	=	Rs.151.25
4. Interest u/s 4(3) @ Rs.6% from 25.10.64 to 30.3.75 (10 years & 157 days).	=	Rs.672.75
