DOCUMENTARY EVIDENCE :-

Shri Ran-hir S/o Shri Paratap Singh an<sup>d</sup> Shri Jit Singh Prahan have filed two photostat copy of Sale Deeds date<sup>d</sup> 28.2.74 & 15.10.71 for a sum of Rs. 45000/- in respect of lan<sup>2</sup> measuring 10 Biswas in khas No. 1200 an<sup>d</sup> for a sum of Rs. 4300/- for a lan<sup>2</sup> measuring 252 Sq. y<sup>2</sup> in khasra No. 1617. Both these sale Deeds are more than 7 years old an<sup>d</sup> pertain to a nearby village Issapur. Besides this the other claimants have claim<sup>e</sup> the compensation of lan<sup>2</sup> at different rates

MARKET VALUE :- Market value of the land under acquisition is to be assessed, keeping in view advantages and potentialities attached to the land and with reference to the price prevailing on or about the date of notification u/s 4 which in this case is 8.8.1980. The best evidence to consider the market value are the genuine sale deeds of land but there has been no sale-transactions in this village as per revenue records maintained in Tehsil. Thus in absence of sale deeds, I have considered the award given by the Land Acquisition Collector(P) in village Issapur @ Rs. 2400/- per bigha which was announced on 2.9.81. The land under acquisition is parallel to the award no. 18/81-82 and under the same notification and for the same scheme. Keeping this fact in view I determine the market value of the land @ Rs. 2400/- per bigha in this village.

OTHER COMPENSATION :-

CROPS :- At the time of possession there was no crops and trees were found on the land under acquisition.

INTEREST :- The possession of the land under acquisition was taken over u/s 17 of the L.A. Act 1894 on 5.11.1980. Therefore, interest @ 6% p.a. will be paid to the interested persons. w.e.f. 5.11.80 to the date of announcement of award.

LAND REVENUE :- The land under acquisition was assessed as land revenue to a sum of Rs. which was deducted from the rent roll of village Bakarganj w.e.f. Rabi, 1980.

APPORTIONMENT :- The compensation will be paid to the interested persons according to the latest entries in the revenue records. If there is any dispute, the amount be sent to the court u/s 30 & 31 of the L.A. Act for adjudication.
