An area measuring 1 bigha 10 biswas was notified U/S 4 and the Land Acquisition Act, 1894 of Village Baprola. The survey required to be taken by the Govt, at the public expense for increasing the capacity of Najafgarh Drain.

MEASUREMENT & TRUE AREA

Necessary measurement was carried out by the field staff at the spot and also revenue record was consulted. The area measured is as under:-

Market Value.

The notification U/s 4 in the instant case was issued
No. F.7(73)/78-L&B(4) dated 30.5.79. In this award
total area measuring 1 bigha 10 biswas is being ^{via} acquisition.
the entire land is under wells. An award No. 100/80-81
already been drawn in this village in which case the date
notification U/s 4 is the same i.e. 30.5.79 as in the
instant case. The compensation awarded in award no. 100/80-81
is Rs. 3250/- per bigha. Accordingly, I determine the
market value of the land in the instant case also at Rs.3250/- P.B.

INTEREST

Seven wells were existing in the land under acquisition.
I assess Rs. 2500/- for each well, Rs. 250/- for removal of
the pipes from the boring.

INTEREST

Possession of the land under acquisition has not been
taken over so far. Therefore, no interest is liable to be paid
to the interested persons.

SOLATIUM

30% solatium will be paid on the market value of the
land.

Additional Amount

The interested ~~persons~~ ^{persons} are entitled to a additional
amount @ 12% on the market value of the land w.e.f. the date of
notification U/s 4 till the date of announcement of the award.

Comment

Payment of compensation will be made as per the latest rates in the revenue records except where persons other than those claimed compensation. In case of any dispute, the amount of compensation will be referred to the court of Additional District Judge, Delhi U/s 30-31 of the Land Acquisition Act, for adjudication.

REVENUE

The land under acquisition is assessed to a sum of Rs. 4875.00 as land revenue. The same will be deducted from the revenue roll of the village Baproal from the date of taking over possession or from the date of announcement of the award.




