NAME OF VILLAGE:

BASAI DARAPUR.

NATURE OF ACQUISITION:

GOVERNMENT.

This is a case for the acquisition of land in village Basai Darapur required by the Government at the public expenses for a public purpose namely for the Establishment of an Industrial Area for the resettlement of displaced persons from Pakistan. A declaration Under Section 3 of the Resettlement of Displaced Persons, Land Acquisition Act, 1948 was made by the Chief Commissioner, Delhi. His notification No. F.1(136)/48-136(1) dated 1.7.11.3.49. No joint offer was made by the competent officer who was also the Land Acquisition Collector of Delhi at that time. Offers in each individual case were made separately. The rates given in those offers were as follows:-

1. Chahl: Rs 210 Per Bigha.
2. Rosli. Rs 168 Per Bigha.
3. Banjar Kadir & Gar-munkin. Rs 140 Per Bigha.

These offers were <sup>not</sup> accepted by the Land owners and the cases were referred to the arbitrator for assessing the prices of the land according to law. Decisions have not been made by the arbitrator so far in these cases except in three cases. The land owners started an agitation stating that the prices given to them on the basis of 1939 were very low and they should get more than the amounts of the offers. The Ministry of Rehabilitation decided that they will make an ex gratia grant of Rs 40 lacs to all the land owners from whom land was acquired under the above act, in addition to the amounts payable legally. A scheme was prepared on this basis and the rate of Basai Darapur on the basis of ex gratia was approved at Rs 100.00 per Bigha for all kinds of land vide D.O. No. F.15(175)/1952. The amount of ex gratia grant is

condition that the land owners withdraw their cases from the arbitrator and accept the amount in full and final settlement of all their claims. Most of the land owners of Basai Darawa have with-drawn their cases, and are agreeable to an compromise on this basis. There is, therefore, a necessity of drawing a fresh offer on the basis of exgratia grant.
