

Award No. : 1862-A (Supplementary).
 Name of the village: : Basaidara-pur.
 Nature of acquisition : Permanent.
 Purpose of acquisition : Planned Development of Delhi.

The Government had acquired land in Khasra Nos. 3242/1239 and 3243/1239 vide award No. 1862 after showing the details of the land in the following manner:

<u>Khasra No.</u>	<u>Area.</u>
3242/1239	2-09 bighas.
3243/1239	<u>7-07 bighas</u>
Total:	9-16 bighas.

It is further noticed from the field book (Bandobasti) that the total area of this field No. 1239 was 10-07 bighas and thus the Government acquired land 9-16 bighas against total area of 10-07 bighas and in fact, area of khasra No. 3242/1239 has now been shown as 2-19 bighas instead of 2-09 bighas in the revenue records vide mutation No. 3447 dated 12.1.67. The Government is, therefore, required to acquire the remaining land measuring 0-10 biswas in khasra No. 3242/1239. The rate of compensation of the land in award No. 1862 was assessed at Rs. 2500/- per bigha. I, therefore, accordingly assess the rate of compensation of the land being acquired at the rate of Rs. 2500/- per bigha.

APPORTIONMENT:

The compensation will be paid on the basis of the latest entries in the revenue records.

15% SOLATIUM:

15% solatium will be paid on account of compulsory acquisition charges as provided in section 23(2) of L.A. Act, 1894.
