Land measuring 229 bighas 14 biswas as described by field numbers given below and situated in village Basant Nager was notified for acquisition under section 4 of the Land Acquisition Act, 1894 vide notification No.F. 15(167)/55-LSG(i)-GI(S-VI), dated the 24th May, 1961, issued under the authority of the Chief Commissioner, Delni for a public purpose namely, for the Planned Development of Delhi. Due publicity was given to this notification as required by law and objections received under section 5A were duly considered by the Local Government. After this a declaration, under section 6 of the ibid Act was issued vide notification No.F. 15(167)/55-LSG(i)-GI(S-VI), dated the 27th July, 1961 in respect of the same area. This declaration was also issued under the authority of the Chief Commissioner, Delhi. Due publicity was given to this declaration as required by law and notices under sections 9 and 10 of the Land Acquisition Act, 1894 were issued to all the persons interested in the Land under acquisition inviting claims for compensation from them. Claims filed by the persons interested are separately discussed under the heading "COMPENSATION: CLAIMS".

TRUM ARBA:

The Land was measured on the spot by the Land Acquisition Field Staff in conjunction with a representative of the requiring Department. On measurement, the true and correct area was iound to be 299 bignas 14 hiswas, of which

MARKET VALUE:

We have to find out the market value of the land as prevailing on the date of notification under section 4 namely the 24th May, 1961. During the last 5 years preceding the date of notification under section 4, a large number of transactions took place in this village which are listed in this file. The above transanctions will indicate the trend of prices during the last 3 years preceding the date of notification under section 4. It is a fact that there has been no rise in prices since the Delhi Administration had issued a notification under section 4 in respect of 34070 acres on 13th November, 1959.

I have inspected the land. It has certainly gained a little importance as building site due to its close vicinity to the various housing schemes of the Government of India. As agricultural land, it is not productive at all and is hilly and does not yield good return but since the Land has gained some importance as building sites, hence it was with that ulterior motive in view that the purchasers had purchased the above land at the rates varying from Rs. 3000/- to Rs. 4000/- per bigha kham. A few awards have also been given in this village in respect of similar lands and in which the date of notification under section 4 is either the same as in this case or very close to it. The rates in these awards were Rs. 3500/-. The land under acquisition is also similar to the Land.involved in these awards and considering all the facts I am of the firm view that Rs. 3500/- per bigha kham is just and fair market value on the date of notification under section 4 namely the 24th May, 1961 and award accordingly.

TREES: WELLS AND OTHER STRUCTURES:

TREES: There are some trees in the land under acquisition which are detailed in annexure 'A' attached to this award. Their total price is assessed Rs. 230/-.

There is no well or structure on the land in question, so the question of payment of compensation does not arise.

APPORTIONMENT:

in the revenue record till today. If any person who has not intimated his title to the compensation, intimates to me in writing his title to the compensation in respect of any field number under acquisition, then that case will be duly investigated.

There are no occupancy-tenants or tenants-at-will in the land under acquisition as entered in the revenue record and also none has claimed compensation on account of his tenancy-rights.

The apportionment of the said compensation among all the persons known or believed to be interested in the land under acquisition, whether or not, they have respectively appeared before me is attached herewith separately as required by section 11 of the Land Acquisition Act, 1894.

15% FOR COMPULSORY ACQUISITION:

As required by section 23(2) of the Land Acquisition Act, 1894, 15% shall be paid on account of compulsory nature of acquisition.
