

Supplementary Offer No.1000-B

Name of the village: B E G U M P U R  
Nature of acquisition: Permanent.  
Purpose of acquisition: Construction of the Quarters  
for the resettlement of displaced  
persons from West Pakistan.

O F F E R

This is a case for the acquisition of land measuring 4.03 bighas situated in village Begumpur under the Resettlement of Displaced Persons (Land Acquisition) Act, 1948. The land is needed for a public purpose and at public expenses, namely for the construction of the quarters for the resettlement of displaced persons from West Pakistan. A declaration U/s 3 of the said Act was issued by the Chief Commissioner vide notification No.F.1(72)/48-LSG(1) dated September 13, 1948. In this notification Kh.No.230 area 4 bighas alongwith other khasra numbers was notified but no offer was given in respect of this land as at this particular time this land was an evacuee property. It was for this reason that khasra No.230 left out in offer No.1000/1000A.

The Competent Officer vide his order dated March , 1966 redeemed Khasra No.230 in favour of Shri Bhondu s/o Summin and Wazira s/o Summin Khan and Smt. Hoshiari B. widow of Jabber Khan. Shri Bhondu etc. have now applied for payment of compensation in respect of khasra No.230 and stated that since this khasra number has been acquired under offer No.1001, the payment of their land so acquired may be tendered to them. As stated earlier, this khasra number was not acquired under offer No.1000A being Custodian property which is now being acquired under this supplementary award.

MEASUREMENT & OWNERSHIP:

According to revenue records, the correct area of khasra No.230 is 4.03 bighas. The ownership of the land is given below:

MARKET VALUE:

According to offer No.1000-A, the land owners will be paid compensation at the rate of Rs.322/-per bigha ~~plus~~ interest at the rate of 4% from the date of taking over possession till the date of tender of payment in the present supplementary offer.

APPORTIONMENT:

The compensation may be paid according to the latest entries in the revenue record.
