Name of the village: Bharthal.  
Purpose of acquisition: M.C.Higher Secondary School.  
Nature of acquisition: Permanent.

Land measuring 3 bighas 1 biswa as detailed by field numbers given under a separate heading 'True and Correct Area' was notified for acquisition under-section 4 of the Land Acquisition Act(I),1894, vide Notification No.F.15(1)/64-LSG. dated 21st May,1964, issued under the authority of the Chief Commissioner, Delhi, for a public purpose namely for the M.C.Higher Secondary School. Due publicity was given to this notification as required by law and no objection under-section 5(A) of the Land Acquisition Act(I),1894, was received. After this a declaration under-section 6 of the ibid Act was issued by the Delhi Administration, under the authority of the Chief Commissioner vide Notification No.F.15(1)/64-LSG. dated 1-12-1964. Due publicity was given to this notification and notices under-sections 9 and 10 of the Land Acquisition Act(I), 1894, were issued to all the interested persons in the land under acquisition, inviting claims for compensation. These claims are discussed separately in this award under a separate heading 'Compensation-Claims'.

TRUE AND CORRECT AREA:

The land was measured on the spot by the Land Acquisition Field Staff in conjunction with the representative of the requiring department. On measurement the true and correct area was found as follows:-

COMPENSATION CLAIMS:

In compliance with notices under-sections 9 and 10 of the Land Acquisition Act(I),1894, Shri Jai Kishan son of Rughnath resident of village Bharthal has filed claim for compensation demanding Rs.6000/-per bigha kham for the land.

The claim of the claimant is exorbitant and fabulous. He has produced nothing material in support of his claim. He is only entitled to the market value as determined by me in this award.

MARKET VALUE:

I have to assess the market value of the land under acquisition as prevailing on the date of Notification under-section 4 namely 21-5-1964. During the five years preceding the date of Notification under-section 4 the following sales took place in this village. The year-wise *Average* of the sales is given below:-

In the year 1963-64, no sale took place in this village. However ~~an~~<sup>m</sup> award No.1103, given in this village, the land acquired under this award is far about one furlong from the land under acquisition.

I have inspected the land in question. It is well-irrigated and is situated on the approach road to the village from the level crossing of the Railway Line.

Giving consideration to the sales and the award announced in this village, I am of the opinion that the fair and reasonable market value of the land under acquisition should be Rs.1000/-per bigha kham and I assess and award the same rate accordingly.

TREES WELLS AND OTHER STRUCTURES: NIL.

APPORTIONMENT: Compensation will be paid on the basis of latest entries in the revenue record and as per award statement prepared from the revenue record.

15% FOR COMPULSORY ACQUISITION: As required by section 23(2) of the Land Acquisition Act, 15% shall be paid on account of compulsory acquisition.


