 PURPOSE OF ACQUISITION : REMODELLING OF BAWATA ESCAPE

These are proceedings u/s 35 of the L.A. Act for determination of compensation in respect of land measuring 99 bighas 16 biswas in village Budhpur Bijapur. The land was required for temporary occupation for a period of one year from the commencement of such occupation (25.4.1970). The temporary occupation was for a public purpose namely for remodelling of Bawata escape. The Delhi Administration made an order u/s 25(1) of the Act in this behalf, issued vide L.O. 15 (95)/G7-L&H dated 15.10.1973.

The persons interested in the land were issued notices to file their claims for compensation in respect of temporary use of land for the period of one year.

Claims filed in response to the notices would be discussed under the appropriate heading 'Claims & Evidence'.

MEASUREMENT AND TRUE AREA

The field staff carried out measurement of the land at the spot. The area 99 bighas 16 biswas was found to tally as per revenue record.

MARKET VALUE

The Government had taken possession of the land originally with effect from 25.4.1969 and the two offers Nos. 2153 and 32/1971-72 for the periods from 25.4.1968 to 24.4.1969 and 25.4.1969 to 24.4.1970 were announced. This offer therefore relates to the acquisition of land temporarily for the period from 25.4.1970 to 24.5.1971. The interested persons have given in writing not to claim compensation for the period from 25.4.1971 upto 29.7.1971 (date of restoring possession). The interested persons have claimed compensation on the basis of judgements of the court as referred to above. I find that the court was pleased to enhance the rate of compensation in LAG No. 10/69 Chandgi Ram and others in the following manner:-

5 bis. and 4 biswas owned by Gach Sabha used as 'Rafe-i-am' and thorough fair respectively are also now under acquisition. No compensation shall be paid for both these Khasra Nos. and hence these Khasra Nos. have not been included in any of the blocks.

There is no reason for me to ignore the evidence produced by the interested persons. I, therefore, assess the rate of rent at the rate of 6% on the ~~rate of compensation~~ ^{market value} assessed by the learned court of A.D.J. in respect of land falling in Block I and Block II. ~~On the basis of collection~~ ^{calculated} the rate of rent will therefore be Rs.72/- per bigha of the land in block I and Rs.48/- per bigha in block II.

MODE OF COMPENSATION

The interested persons shall be paid compensation according to the latest entries in the revenue record.
