PURPOSE

Remodelling of Bawana Escape.

NATURE OF ACQUISITION:-

Temporary u/s 35(1)

AWARD

In pursuance of notification No. F15(95)/67-I&H(IV) dated 2.2.68 issued u/s 35(1) of the L.A. Act, 1954 for remodelling of Bawana Escape, and offer No. 2153 in the said village was announced on 14.8.68 for occupation of land measuring 99 bighas 15 biswas for a period of one year with effect from 25.4.68 to 24.4.69. After the expiry of one year and on the request of the department concerned the period was extended for one year more vide notification No. F15(95)/67 I&H dated 11.370. The rent for the second year has also been given to the owners of the land vide offer No. 32/71-72.

Now these are the proceedings for awarding damages for removing earth from the land in question. The claims have been discussed separately under the heading 'Claims'.

Measurement and details of land and its classification have already been discussed in the main offer.

Now the present proceedings are concerned for 82 bighas 11 biswas for awarding damages for removing earth. The earth was not removed from the remaining area measuring 17 bighas 4 biswas. For purposes of awarding damages, land in question has been grouped into four blocks and the Khasra Nos. included in these blocks are indicated separately. The grouping has been done on the basis of the depth upto which digging has been carried out and earth removed.

In support of their claims, no one has produced any evidence; therefore, damages shall be fixed as per rules.

QUANTUM OF DAMAGES

This village is governed under the Delhi Land Reforms Act, 1954 and no area is now under the cultivation of any tenant at will. The land was acquired temporarily under section 35(1) of the L.A. Act for removing the earth for remodelling of Bawana Escape. The rent has already been paid vide offer No. 2153 & 32/70-71.

Now the owners have claimed for the damage of removing the earth. The depth and the area from which the earth was removed was measured at the spot by the field staff in the presence of the Section Officer, Flood Control and Drainage Deptt., Delhi, Division No. II. The area of such land comes to 82 bighas and 11 biswas. The quantum of earth removed is not equal but different. For assessing the damage the land has been divided in blocks according to the depth of the earth removed. The details blockwise are as under:-

The land from which the earth removed upto 4 feet is kept in Block 'A', 3 feet in Block 'B', 2 feet in Block 'C' and upto one feet in block 'D' as under:-

The area from which the earth was not removed is 17 bighas and 4 biswas.

The claimants have generally claimed Rs.8/- per 100 sq. ft. as damage but no proof has been produced. The demand of the land owners is abnormally high and exaggerated.

In determination of compensation for digging the earth, it is proper to consider other temporary awards. As there is no such case in this village and no documentary evidence has been produced by the owner so it is necessary to consider offer No. 1792 & 1818 of village Wazirabad *vide* notification u/s 35(1) No. F15(2)/65-LSG and No. F15(15 /65-LSG dated 22.4.65 in which the rate of Rs.26/- per bigha for digging the earth upto a depth of 2 ft. was given. In offer No. 61A of 1970-71 announced on 30.3.72 by the L.A.C(N) damage for digging the earth was given @ Rs.15/- per bigha per foot. This is a fit case on which the compensation can be assessed. So I am of the *xi* opinion that the damage be assessed @ Rs.15/- per bigha per foot i.e. for block A Rs.60/- per bigha, for block B Rs.45/- per bigha, for Block C Rs.30/- per bigha and for Block D Rs.15/- per bigha. Accordingly I assess the same in respect of Blocks 'A', 'B', 'C' & 'D'.

MODE OF PAYMENT

Kunwar

The persons interested shall be paid the compensation of damage according to the latest entries in the revenue records of the land, now under proceedings. Before making payments, if any objection is received from any person the payment may be made after any amicable settlement between the parties concerned failing which the matter may be referred to the court of A.D.J., Delhi for adjudication.
