 NAME OF THE VILLAGE BURARI
 PURPOSE OF ACQUISITION CONSTRUCTION OF SUB MINORS
 NATURE OF ACQUISITION PERMANENT

These are the proceedings for determination of compensation u/s 11 of the Land Acquisition Act, 1894. The land situated in village Burari was notified u/s 4 of the L.A. Act vide notification No. F.7(83)/78-L&B(1)/4005 dated 9.2.79 for a public purpose namely for the constructions of sub-minors. In view of the urgency of provisions of sub section (1) of section 17 of the L.A. Act are applicable to this area. Hence the interested persons were not given any opportunities to file their objection u/s 5-A of the L.A. Act. The Delhi Administration issued a declaration u/s 6 of the L.A. Act through same notification.

In pursuance of the above notification u/s 6 notices u/s 9 & 10 of the L.A. Act were issued to all the interested persons to file their claims and the claimants filed the claims which are discussed hereafter under the heading "CLAIMS".

MEASUREMENT :-

The area under acquisition have measured on the spot and found correct, the details of khasra Nos. & area is as under

MARKET VALUE :-

The land under acquisition is governed by the provisions of the Delhi Land Reforms Act, 1954 and as such, it cannot be used for the purposes other than agriculture, horticulture etc. without the prior sanction of the prescribed authority.

The claimants have claimed compensation @ Rs. 50/- per sq. yd to Rs. 60,000/- per bigha for the land but have not produced any documentary evidence in supports of their claims. In the absence of documentary evidence no reliance can be placed on their claims. Efforts were made by the revenue field staff to ascertain the details of sale deeds/awards which was executed or drawn in this village in the vicinity of date of notification u/s 4 i.e. 9.2.79. The following awardes were announced in this village :-

The date of notification u/s 4 in the present case is 9.2.79. The awards mentioned at S.No. 1 to 2 will not help us in this case as the awards was announced about 7 years ago. The award mentioned at S.No. 3 to 5 are also after the date of notification u/s 4 i.e. 9.2.79 in the present case. Hence these three awards could not give us some any guidance in determining the market value of the land. Award No. 13/83-84 mentioned at Sl.No. 6 can also help us in determining the value of the land under acquisition. There is a difference of about 2 years between the two notification i.e. present case and award No. 13/83-84. It would be justified if some element interested is added for this difference of time then the value of the land comes to Rs. 2100/- approximately per bigha.

I think it would be fair and reasonable if I assess the market value of the land at rate of Rs. 2100/- per bigha and accordingly awarded the same.

TREES, WELLS AND STRUCTURES :- There is no well, trees and structures on the land under acquisition.

INTEREST :- The possession has already been handed over and taken over on 22.8.79. Hence the interested persons are entitled to get the interest @ 9% p.a. from the date of possession to the date of announcement of the award i.e. 22.8.79 to 19.9.86 (7 years, 29 days).

ADDL. AMOUNT U/s 23(1A) OF THE L.A. ACT :- The interested persons are entitled to get the Addl. amount @ 12% p.a. on the market value of the land from the date of notification u/s 4 to the date of possession, i.e. 9.2.79 to 21.8.79 (105 days)
