Purpose of Acquisition	Construction of eastern shanks & studs along RME(old) in the reach from Wazirabad Barrage to Bawana escape.

These are the proceedings for determination of compensation U/s 11 of the LA Act for the crops standing on the land in village Brari acquired under Award No. 65/80-81. The land measuring 104 bighas 12 biswas was acquired under award no.65/80-81 and the possession of which was taken only on 14.5.79. In the possession report, no crops was shown. Hence, no compensation of crops was assessed in the said award. Now the acquiring department i.e. Flood Control Department has informed this office that there ^{were} ~~was~~ some crops of Jaid Rait on the acquired land at the time of taking over the possession, which were destroyed by the acquiring department. In this regard, revenue record has been consulted and found that the informations of the acquiring department is correct. Hence, assessment of compensation for the crops has become compulsory. Details of crops available from the khasra girdawari for the year 1978-79 are as under :-
