NATURE OF ACQUISITION PERMANENT

This is a case for acquisition of land measuring 130 bighas 15 biswas situated in Village Jharoda Mazra Burari & Burari vide Notification No.F.15(27)/53-MT&CE(ii) dated the 20th July,1953, for the Jagatpur Co-operative Multipurpose Society Ltd registered under the Societies Registration Act VII of 1925 for Abadi site as the original abadi has been cut off by the Yamna River. As required under Sec.41 of the Land Acquisition Act, 1894, an agreement duly approved by the State Government under its letter No.F.15(27)/53-MT&CE dated the 17th September, 1953, was executed by the President of the Society on 17.2.53 and the State Govt.

was requested vide this office letter No.1312/LAC dated 29.12.53 to publish it in the State Gazette as required by Sec.42 of the Act. The preliminary notification No.F.15(27)/53-MT&CE U/s 4 of the Land Acquisition Act was issued by the State Government on 17th June 1953.

MEASUREMENT & CLASSIFICATION.

Land measuring 76 bighas 5 biswas out of 130 bighas 15 bis. is situated in Village Burari. This land is classified as Selah and is without permanent means of irrigation.
