PURPOSE OF ACQUISITION

FOR INCREASING THE CAPACITY OF NAJAFGARH DRAIN.

These are the supplementary proceedings of Award No. 49/82-83 which was announced on 8.11.1982. The land in this case was notified u/s 4 vide notification No. F.7(103)/79/L&B(i) dated 13.1.81 for increasing the capacity of Najafgarh Drain. Possession of the land was taken over on 27.2.1981. The total area acquired in this award was 4 Bighas

After the announcement of the above award, the Land Acquisition Act, 1894 has been amended and the Amendment Act came into force w.e.f. 24.9.84. However, as per provision of section 30 of the Land Acquisition (Amendment) Act, 1984, certain provisions of the Act are to take effect from 30.4.82. Hence, the need for the supplementary award has arisen.

Under the A mended Act, the provisions of section 23(1) have been amended by providing a new sub-section 1(A) of section 23 of the Principal Act as inserted by clause A of section 15 of the Amended Act. By this amendment, the interested persons will get an amount calculated 212% p.a. on the market value for the period commencing on and from the date of publication of the notification u/s 4 till the date of the award of the Collector or date of taking over possession of the land which—ever is earlier. Similarly, section 23(2) of the Principal Act has been amended by clause A of section 15(b) of the Amendment Act by which the interested persons will be entitled solatium 230% instead of 15%. Section 34 of the Principal Act has also been amended by section 20(b) Contd..2...

of the Amendment Act by which the interested persons will be entitled interest @ 9 % for the first year and 15 % for subsequent years instead of 6 % from the date of possession till the Amendment are to take effect from 30.4.82 as per provision of section 30 of the Amendment Act, 1984.

Keeping in view the provisions of the Amended Act, the interested persons/bhumidars of Award No. 49/82-83 which was announced on 8.11.1982, are entitled for payment of solatium @ 30 % on the market value, 12 % as Additional amount w.e.f. 13.1.81 to 26.2.81 & Interest @ 9 % from 27.2.81 to 7.11.82.

As per above discussion, the following amount is allowed to the interested persons of the above award. This amount shall be apportioned as per the original award No. 49/82-83.

PURPOSE OF ACQUISITION: FOR INCREASING THE CAPACITY OF NAJAFGARH DRAIN.

These are proceedings for determination of compensation u/s 11 of the Land Acquisition Act, 1894.

The land situated in village Chhawla measuring 4 bighas
4 biswas was notified u/s 4 of the L.A.Act vide notification
No.F.7(103)/79-L&B(i) dated 13.1.81 for a public purpose
namely for Increasing the capacity of Najafgarh Drain.

Provisions of sub-section (1) of section 17 were also
applicable to this area. Hence the interested arsons were
not given any opportunity to file their objections u/s 5-A
The Delhi Administration issued a declaration u/s 6 of
the said Act vide notification No.F.7(103)/792L&B(1)
dated 13.1.81. In pursuance of the above declaration u/s 6
notices u/s 9 & 10 were issued to all the interested person
to file their claims. The claims filed by them are
discussed under the heading 'Claims'.

ME ASUREMENT AND CLASSIFICATION OF LAND

tion u/s 6 is 4 bighas 4 biswas. At the time of measuremen by the field staff it was found tobe 4 bighas only. The difference of 4 biswas is due to the fact that out of Kh. No.85/2 and 85/3, one biswa and three biswas/have already been acquired vide award No.31/80-81 alongwith other Khasra numbers. Hence, 4-00 bighas is being acquired in this case.

The land owners have not raised any objection regarding the measurement & shars classification of the land. POS SESSION

The possession of the land under acquisition has been taken over and handed over to the Acquiring Department on 27.2.81.

MARKET VALUE

The market value of the land is Carrowsty tobe assessed after keeping in view the situation, advantages and potentialities attached to the land on the date of notification under section 4 of the Land Acquisition Act. The land use is also to play an important role in deciding the market value of the land. It has been seen that the provisions of the Delhi Land Reforms Act are applicable and thus restrictions contemplated under section 22 and 23 of the Delhi Land Reforms Act are applicable and land can only be used for agriculture, horticulture or animal husbandry etc.

The claimants have claimed compensation @ Rs.100/per sq.yd. but have not produced any documentary evidence in
support of their constention. Thus the claims appear tobe
exhorbitant. In order to determine the market value of
this land, sale transactions and previous awards are tobe
considered. 8 awards are reported to have announced in
this village but the following two awards appear tobe
relevant in this case:-

Out of the above two awards award No.124/80-81 is later in time. Moreover the land in this case is situated on one side of the road whereas on the otherside the land is being acquired in the present case. I therefore make award No. 124/80-81 basis in this case for determining the market value of the land. The date of notification u/s 4 in the above award is 20.5.72 whereas in the present case it is 13.1.81. After giving appreciation of 6% per annum on the

market value of the above award, it would be fair and reasonable if the market value of the land is a ssedsed @ Rs. 2750/- and I award the same accordingly.

There is no tree, well & structure on the land now under a equisition.

CROPS

There are wheat crops in Kh.No.83 $\frac{85}{24/1,25/1}$, $\frac{85}{3/2/1}$

total measuring 3 bighas 12 biswas. Forxwhich The werage yield of wheat per bigha ranges from 250 kilogrammes to 300 K.G. whereas the average of fodder would be double than that of the yield of wheat. Keeping in view this, I fix a sum of Rs.450/per bigha for the crops. In case they have been allowed to harvest their crops by the Flood Department, they will not be paid compensation on this account. The payment in respect of crops may be made after confirming from the Flood Department.

SOLATIUM

As provided under sub-section 2 of ection 23 of the L.A. Act 1894, the persons interested are entitled to have 15% solatium on the market value of the land.

INTEREST

The possession of the land has been taken over on 27.2.81. So the persons interested are entitled to have interest on the market value from the date of taking over possession till the announcement of the award.

APPORTIONMENT

Them persons interested shall be paid compensation according to the latest entries in the revenue records. In case of any dispute the payment shall be made after any amicable

settlement between the parties concerned, the matter shall be referred to the court of Additional District Judge, Delhi for a djudication.

Thek land revenue worked out to Rs.O-37 shall be deducted BAND REVENUE DEDUCTION from the rent roll of the village w.e.f. taking over possession of the land.
