MEASUREMENT AND AREA

Necessary demarcation and joint survey was carried out on the spot in the presence of field staff from L&B, Irrigation and Flood and Revenue Deptts The total area notified u/s 4&6 was 0-02 bigha of village Dichaon Kalan. The possession of land area measuring 0-02 bigha bearing Khasra no.3/15min has already been handed over to L&B Deptt and further to I&F Deptt on 30thAugust, 2000.

CLAIMS & EVIDENCE

No claims received in response to the notices u/s 9 and 10 LA Act.

MARKET VALUE

The market value of the land under acquisition is to be determined with reference to the date of Notification u/s 4 of the LA Act 1894, which is 29-3-2000 in this case. For determination of the market value of land the indicative price fixed by the Govt of NCT of Delhi for agricultural land in Delhi is Rs.11.20 lacs per acre conveyed by letter no.9(20)/80/L&B/LA9229-38 dated 24/9/98 and the same was taken into consideration. Accordingly, the market value of the land under acquisition is

determined as @ Rs. 11.20 lacs per acre or Rs.233333/- per bigha. In addition to the market value the landowners will be entitled to solatium and other benefits as per the provisions of the land acquisition act.

30% solatium will be given to the interested persons due to compulsory nature of acqusition u/s 23(I) of LA Act, 1894

ADDITIONAL AMOUNT

Besides the market value fixed, interested person are also entitled to have additional benefits @ 12% per annum on the market value u/s 23(1)(A) of the Land Acqusition Act, 1984 from the date of Notification Under Section 4 of the Act i.e. 29-3-2000 till the date of possession i.e. 30-8-2000.

INTEREST

Besides Market Value fixed as above, the interested persons are also entitled to rate of 9% per annum from time of taking possession until it shall have been so paid or if not paid within the period of 1 year from the date on which possession is taken interest @ 15% per annum shall be paid from the date of expiry of the said period of one year and the amount of compensation or part thereof which has not been paid before the date of such expirty. In this case interest of 9% per annum is to be paid from the date of possession i.e. 30-8-2000 to 29-8-2001 and interest @ 15% p.a. from 30-8-2001 to the date of award.

APPORTIONMENT

The compensation as assessed is allowed to the recorded owners of the land as per the share of each recorded owner mentioned in the revenue records. If there is any dispute regarding apportionment, the same may be referred to the Court u/s 30-31 of LA Act.

LAND REVENUE

The Land Revenue will be deducted from the rent roll of the village w.e.f. taking over the physical possession.
