 NATURE OF ACQUISITION : PLANNED DEVELOPMENT OF DELHI.  
 PURPOSE OF ACQUISITION : PERMANENT.

These are proceedings U/s 11 of the Land Acquisition Act 1894 to determine compensation in respect of land measuring 499 bighas 08 biswas situated in village Ghonda Gujran Khadar. The land forms part of the general notification issued by the Delhi Administration U/s 4 L.A. Act vide No. F.15(245)/60-LSG-L&H dated 24.10.61 for 16000 Acres Scheme. A declaration U/s 6 of the Act was issued vide No. F.4(19)/65-L&H(ii) dated 2.9.1966 for area 2659 bighas 06 biswas.

The land is required by the Government at the public expense for a public purpose namely for the Planned Development of Delhi.

Notices U/s 9 & 10 of the Act were issued to the persons interested in the land. Claims filed in response to the notices, will be discussed under the heading "Claims & Evidence".

#### MEASUREMENT & CORRECT AREA:

As mentioned, the present proceedings are confined to an area measuring 499 big. 08 bis., which was found to be correct at the spot on measurement <sup>by</sup> the field staff. The remaining area notified U/s 6 of the Act, will be acquired through supplementary proceedings.

MARKET VALUE:

The date of preliminary notification in the present case is 24.10.61 and as such the market value is to be determined as prevailing during that period.

The claimants have demanded very high rate of compensation, without adducing any evidence to substantiate their claim.

Before we embark upon the sale transactions, finding place in the revenue record of this village, it would be appropriate to also look into the awards relating to acquisition of land in the village. Only one award has so far been made in this village near about the material date in the present case, the detail of which is as below:

The above award can be the best guide in determination of the market value for the land under acquisition as firstly the land in the said award is similarly circumstanced and secondly the land acquired is in close vicinity to the land in the present case.

Some of the person interested preferred reference petition U/s 18.L.A.Act ( 1894) against the award. The Learned Additional District Judge in L.A.Case No. 384/1962 decided on 12.7.1963 Ram Lal & others enhanced the market value of Chahi & Nehri land from Rs. 370/- to Rs.670/- and that for Rosli & Bhood land from Rs. 250/- to 450/-. The decision of the court with regard to the land in the same vicinity & similarly circumstanced <sup>and</sup> the best guide in determination of the fair market value.

As already said the land under acquisition has the same characteristics, therefore it would be fair and reasonable to be ~~guided~~ <sup>guided</sup> hereby the decisions in the aforesaid case.

There is time gap of seven months in between the date of preliminary notification covering the land in Award No. 1169 and of the present case, it would therefore be fair to allow some margin on the rates awarded by the Court. I therefore award a rate of Rs. 700/- p.b. for land clasified as Chahi and a rate of Rs. 480/- p.b. for the land clasified as Rosli, Matiyar and Dakar. (Annexure 'I')

It has been observed that earth has been excavated to the extent of two to six feet from the land measuring 44 big. 16 bis. comparing of Kh.No. 404,413,481,487,534 & 536. It is obvious that some money would be required to bring this part of the land to the level of the other land and as such a sum of Rs. 200/- p.b. would be deducted from the market value of this land as awarded above. (Annexure 'I')

Land measuring 4 bigha 13 biswas is Kh.No. 482 & 531 is owned by Gaon Sabha and recorded as G.M.Rasta. This land is for common user and as such no compensation Contd...18/- ~~for compensation~~ is awarded for the same.

OTHER COMPENSATION:

STRUCTURES:

Small structures in the Kh.Nos. 487, 529, 532 & 543 have come up recently i.e. after the date of preliminary notification and as such no compensation is awarded under this heading. The owners are at liberty to remove the 'Malma' at site within 15 days from the date of the announcement of the award.

WELL:

There is only one well in Kh.No. 415. The Naib Tehsildar has assessed a sum of Rs. 1500/- as the value of the well. I consider the same to be reasonable and award accordingly. The compensation ~~is~~ value will be paid on furnishing the proof regarding its existence prior to the date of notification U/s 4 L.A.Act.

There are also two Tube-well and pucca water channel in Kh.No.s 408 & 523. Since the same have come up after the date of preliminary notification, therefore no compensation is assessed for the same. The owner is at liberty to remove the 'Malma' and the Tube-well within 15 days from the date of announcement of award.

TREES:

There are the following trees in the Kh.Nos. noted below. The Naib Tehsildar has assessed the value of the trees noted against each, which I consider to be reasonable and award accordingly.

INTEREST:

The case falls within the purview of Land Acquisition (Amendment & Validation Act) 1967 and as the date of notification U/s 4 L.A. Act is 24.10.1961, while the declaration U/s 6 of the Act was issued on 20.9.1966. Therefore interest would be payable at 6% per annum only <sup>on</sup> the market value of the land w.e.f. 25.10.1964 to the date of announcement of the Award which is tentatively fixed as 14 March, 1973.
