Nature of Acquisition Permanent
Purpose of Acquisition Construction of Nallothi minors & Sub minors under the scheme Keshopur Effluent Irrigation Scheme Phase II.

These are the proceedings for determination of compensation u/s 11 of the L.A. Act 1894 in respect of the land measuring 19 bigha 06 biswas situated in village Jafarpur alias Hiran Kudna notified u/s 4 of the L.A. Act vide notification No. F. 7(10)/85 L&B dated 10-5-85 for a public purpose namely construction of Nallothi Minors & sub minors under the scheme Keshopur effluent irrigation Scheme Phase II. In view of the urgency of the scheme the provision of Sec. 17 (a) of the L.A. Act was also made applicable to this land. The Delhi Administration issued a declaration u/s 6 of the L.A. Act vide notification No. F 7(10)/85 L&B dated 10-5-85.

In pursuance of the above notification u/s 6 notices u/s 9 & 10 of the L.A. Act were issued to all the interested persons to file their claims which are discussed here after under the heading "Claims".

MEASUREMENT

The area covered by the aforesaid notification was measured on the spot by the L.A. Staff and the same was found correct as per the following details:-

MARKET VALUE:

The market value of the land to be determined after keeping view the situation advantages and potentialities attached to the land at the time of notification u/s 4 of the L.A. Act. The land use is also to play an important role in deciding the market value of the land. It has been seen that the provisions of Delhi Land Reforms Act are applicable of thus restriction contemplated under section 22 & of Delhi Land Reform Act are applicable and the land can only be used for agriculture horticulture & animal husbandry.

The land owners have claimed compensation ranging from Rs. 1.30 per acre to Rs. 5=00 lakhs per acre. A list of sale deed/mutations for years 1982-83 and 1983-84 is as under:

There are 10 sale deed executed in this village in the year 1983-84. But in both years the sale deeds were executed for a small piece of the land mostly. The average of these sale deeds were Rs. 11016/- in the year 1982-83 and Rs. 10360/- in the year 1983-84. These small sale deeds were executed only to increase the market value of the land, therefore, I do not consider it fair and reasonable base to determine the market value and hence I discard the same.

One award No. 1/1985-86 was announced in this village @ Rs. 2700/- per bigha. The land in t is award was notified u/s 4,

x17 of the L.A. Act on 13.1.81. There is about 4 years and 4 months gap between the two notification. For argument purposes if element of appreciation is added the figure amounting to Rs.4000/- per bigha comes.

Taking into consideration all the facts and the trend of the prices which were increasing day by day, I assess the market value Rs.4000 per bigha which is fair and justified and award the same accordingly.

COMMISSION

As provided under sub-section (2) of Section 23 of the Land Acquisition Act the interested persons will be paid @ 20% on the market value of the land due to compulsory nature of the acquisition as per provision of the Land Acquisition Act 1984.

POSSESSION

The possession of the land under scheme has been taken over and handed over to the Acquiring Deptt. on 28.2.86.

INTEREST

The possession of the land under scheme has been taken over and handed over to the Acquiring Department on 28.2.86 under Section 17 of the Land Act 1984. Hence interest is payable on the compensation from the date of taken over the possession upto 1 year @ 9% and afterwards @ 15% upto the date of announcement of award.

ADDITIONAL AMOUNT

The interested persons are entitled to additional amount of 12% on market value of the land w.e.f. notification under section 4, till the date of possession.

STRUCTURE & TUBE WELL

There is one Tube well in Khasra No.773 and one Hothe and boarding in Khasra No.776 and 785 are also boarding I assessed the compensation of Rs.3000/- for tubewell Rs.500/- for Hothe and Rs.200/- for boarding each for removal.
