INTRODUCTION:

These are proceedings for the determination of compensation u/s 11 of the L.A. Act, 1894. The land measuring 43.17 bighas situated in village Holambi Ward was notified u/s 4 read with section 17 and section 6 of the Land Acquisition Act vide notification Nos. F.14(42)/68-LAH(i) & F.14(42)/68-LAH(ii) & F.14(42)/68-LAH(iii) dated 10.6.1968 for a public purpose namely for the construction of the drain. In pursuance of the said notifications, notices u/s 9 & 10 of the L.A. Act were issued to all the interested persons and the claims which were received from them are discussed hereafter under the heading 'compensation claims'.

TRUE STATEMENT

The area under acquisition as given in the declaration u/s 6 is 43.17 bighas and the same has been found correct at the time of measurement by the field staff of this office.

 to above operations. The above khasra numbers have ceased
 and have now been given a part of new khasra number 76.

POSSESSION

The possession of the land was taken by the Government
 (Drainage Department) on 26.11.1968.

MARKET VALUE

The market value of the land under acquisition is the value to the owner of the land in its actual condition at the time of publication of notification u/s 4 of the Land Acquisition Act and with all its advantages and with all its potentialities. The best evidence available to arrive at the correct market value of the land would be the evidence of the genuine sales effected about the time of notification either in respect of land under acquisition or a portion thereof or sales of land precisely parallel in all respects to the land under acquisition or judicial judgments or awards.

The following awards have since been announced in

Award No. 1429 is not relevant as the date of notification in this award is 7.1.61 while the date of notification u/s 4 of the L.A. Act in the present case is 10.6.68. It is however, added that the court of A.D.J. had dismissed the reference petitions against this award. The other award No. 1657 is also not relevant as the date of notification u/s 4 of the Act in this award is 24.11.63 while the date of notification u/s 4 of the Act in the present case is 10.6.68. It is however, added that the court of A.D.J. had enhanced the rate of compensation from Rs.540/- to Rs.1450/- in case No.483/66, obviously on the ground that the land in this award was nearer to the village abadi. After taking into consideration all factors, I, therefore, assess the rate of compensation of the land which is being presently acquired at Rs.1500/- per bigha.

TREES, WELLS & STRUCTURES

There was no tree, well or structure on the land under acquisition at the time of taking over its possession.

CROPS

The Revenue staff has reported the existence of following crops at the time of taking over possession of the land in November, 1963, which was the time of ploughing and sowing the land. I, therefore, assess the damage of the crops @ Rs.40/- per bigha.

SOLATIUM

The persons interested are entitled to 15% solatium on the
awarded amount for compulsory acquisition of land also.

INTEREST

Since the possession of the land under acquisition has been
taken on 26.11.1968 by the Govt., the persons interested in the land
are entitled to interest @ Rs.6/- per annum from 26.11.68 to the date
of announcement of the award.

APPORTIONMENT

The payment of compensation shall be paid to the recorded
owners according to the latest entries in the revenue record pro-
vided there has been no change in ownership on account of consoli-
dation or holding of operations.

LAND DIVIDING DEDUCTIONS

The land under acquisition is assessed to 0.14.66 as land
revenue. The same shall be deducted from the Khalsa Rent Roll
w.e.f. Rabi 1968-69 i.e. from the date of taking over possession of
the land.
