

AWARD NO. 12/74-23

Name of the village : Nolumbi Khurd.

Nature of acquisition: Permanent.

Purpose of acquisition: For Bhawana Escape.

INTRODUCTION:

These are proceedings for the determination of compensation u/s 11 of the Land Acquisition Act, 1894. The land measuring 1-17 bighas situated in village Nolumbi Khurd was notified u/s 4 read with section 17 & 6 of the Land Acquisition Act vide notification Nos. P.15(25)/67-LAII(i), (ii) & (iii) dated the 11th February, 1970 for a public purpose namely for the Bhawana Escape. In pursuance of the said notifications, notices u/s 9 & 10 of the L.A. Act were issued to all the interested persons at that time and the claims which were received from them are discussed hereafter under the heading 'Compensation & claims'.

True and correct area:

The area under acquisition as given in the declaration u/s 6 is 1-17 bighas and the same has been found correct at the time of measurement of the field staff of this office.

Classification of land:

The details of field numbers in form 7-A have been prepared u/s 55 of the Financial Commissioner's order No.28 which are as under:

Claims & Compensation:

In response to the notices u/s 9 & 10 of Land Acquisition Act, the following persons have filed their claims:

The following awards have since been announced in village Holambi Khurd:

Award No. 1429 is not relevant as the date of notification in this award is 7-1-61 while the date of notification u/s 4 of the L.A. Act in the present case is 11-2-1970. It is however, added that the court of A.D.J. had dismissed the reference petitions against this award. The other award No. 1657 is also not relevant as the date of notification u/s 4 of the Act in this award is 24-11-63 while the date of notification u/s 4 of the Act in the present case is 11-2-1970. It is however, added that the court of ADJ had enhanced the rate of compensation from Rs.540/- to Rs.1460/- in case No. 403/66, obviously on the ground that the land in this award was nearer to the village abadi. In other award No. 57/73-74 of village Naya Bans, for the construction of Naya Bans Link Drain, the rate of compensation was awarded as Rs.1500/- per bigha. After taking into consideration all the three awards referred to above, I assess the rate of compensation of the land which is presently acquired at the rate of Rs.1500/- per bigha.

#### Tree, Well & Structure

There is no tree, well & structure on the land under acquisition.

#### Interest:

Since the possession of the land under acquisition has not been taken over, the question of interest does not arise.

15% solatium:

The persons interested are entitled 15% solatium on the awarded amount for compulsory acquisition of land also.

Abortionment:

Since changes of owners are reported to have taken place on account of consolidation holdings operations and that Shri Chand s/o Ganga Ram and Shri Umed Singh etc. have also intimated the change of ownership of the land and the change of numbers of fields, I hereby direct that the entire amount is to be sent to the court of learned A.D.J. for adjudication of titles u/s 30-31 of the Land Acquisition Act.

Land Revenue:

An amount of Rs. 0.97 is payable as land revenue which will be deducted from the Khatuni of the village from the date of taking over possession. The aforesaid land will vest absolutely in the Govt. free from all encumbrances from taking over possession.
