After the announcement of the above award, the Land A guisition Act, 1894 has been amended and the Amendment Act came into force w.e.f. 24.8.84. However, as per provisions of section 30 of the Land Acq uisition (Amendment) Act, 1984, certain provisions of the Act are so take effect from 30.4.82 Hence, the need for the supplementary award has arisen.

Under the amended Act, the provisions of section 23(1) have been amended by providing a new sub-section (1(A) of section 2 3 of the Principal Act as inserted by clause A of section 15 of the Amended Act. By this amendment, the interested persons will get an amount calculated @ 12% p.a. on the market value for the period commencing on and from the date of publication of the notification u/s 4 till the date of the award of the Collector ordate of taking over possession on the land whichever is earlier. Similarly, section 23(2) of the Principal Act has been amended by clause A of section 15(b) of the Amendment Act by which the interested persons win be entitled sclatium @ 3% instead of 15%. All these gamendments are to take effect from 30.4.82 as per provisions

Keeping in view the provisions of the amended act, the interested persons/bhumidars of Award No. 37/84-95 which was announced on 13.2.85 are entitled for payment of solutium @ 30% on the market value, 12% as additional amount w.e.f. 12.1.84 to 17.2.84 and 9% interest w.e.f. 18.2.84 to 13.2.85.

As per above discussion, the following amount is allowed to the interested persons of the above award. This amount shall be apportioned as per the original award No. 37/84-85.
