#### OFFER

These are proceedings for the determination of damages under sub-section 2 of section 36 of the Land Acquist tion Act as the result of removal of earth during temporary occupation of land acquired for a period of one year in pursuance of notification No.F.7(8)/70-L&B dated 11.3.70 issued U/s 35(1) of the L.A.Act 1894. The details of the land which was under temporary occupation for a period of one year and from which earth was removed is given below.

Has claimed compensation for the removal of earth from his land. Has also claimed & 16000/-towards the cost of a well which said to have been damaged by the acquiring department.

12. Priya Dutt, Om Dutt, Som Dutt, Dec Dutt, Shankar.

Have claimed compensation for the removal of earth from their land.

DOCUMENTARY EVIDENCE: No documentary evidence whatsoever was filed by any of the claimants in support of his claim.

MARKET VALUE:

This village falls within the purview of the Delhi Land Reforms Act under which sub-letting is not enjoined. Section 35 of the Adt lays that apart from disabled persons no bhumidhar or asami shall lease for any period, whatsoever, any land comprised in his holding. That being so it is not possible to get any mutation by way of lease hold rights executed for temporary occupation of land. Local enquiries further reveal that no sub-letting has been made in the village even by disabled persons as found U/s 36 of the In the absence of any relevant material for the assessment of damages Sh. Balwant Rai Kapoor, Sub-Inspector (Quarries), Revenue Unit, Deputy Commissioner's Office, Delhi was examined to give his expert opinion with regard to the damages caused as the result of removal of earth. The Executive Engineer, Flood Control Drainage Division No.II in his letter No.EE/II/F-5-A/ROC/VIII/1458 dated March 30, 1973 has stated that earth to the depth of 2 feet was excavated from the land under their temporary occupation. Shri Balwant Rai Kapoor who has an expert knowledge of this subject has stated that the cost of a truck-load of earth measuring 5 cubic metre is sold @ &.2/-to &.2.50P in the areas which are in the vicinity of brick-kilns. In the

remote areas where there are no constructions activities, the cost of one truck-load of earth is k.1/-. Reliance can be placed on the testimony of Shri Kapoor based on his personal knowledge and experience according to which in a remote area like this, the cost of earth measuring 5 cubic metre can be taken as k.1/-. With the above rate, the cost of earth for 1 bigha could be as under:-

Cost of 514 cubic metres of  $= 514 \times 1 = \% \cdot 102/-\text{for one}$  earth.

In accordance with the above calculation, the damages caused due to removal of earth is assessed @ R. 102/-per bigha.

APPORTIONMENT: Payment of compensation will be made on the basis of latest entries in the revenue record.

## SUMMARY OF THE OFFER:

Compensation for damages U/s 36 of the L.A.Act for an area measuring 208 bighas 7 biswas @ h.102/-per bigha.
