These are the supplementary proceedings of Award No. 25/84-85 announced on 24.8.84. After the announcement of the above a award, the Land-Acquisition-Act 1894 has been amended and the amendment came into force with effect from 24.9.84.

Under the Amendment Act (68 of 1984) the provisions of subsection 2 of sect 23 have been-amended by clause (b) of section 15 of the Amendment Act and which provides solatium @ 30%. A new sub-section (1-A) of section 23 of the Principal Act, has also been inserted by clause (a) of section 15 of the Amendment Act-which-provides 12% p.a. on the market value w.e.f. date of notification u/s 4 (1) uptodate of Award of the Collector.

As-per provisions of section 30 of the Amendment Act-1984 the provisions of sub-section (1-A) of section 23 of the Principal Act as inserted by clause (a) of section 15 of the Amendment Act and sub section (2) of section 23 as amended by clause (h) of section 15 shall also apply in every proceedings for acquistion of any land under the Principal Act-pending on the 30th day-of April, 1982 (the date of introduction of Land Acquistion (Amendment) Bill 1982, in the House of People) in which no award has been made by the Collector before the date.

- Keeping in view of the provisions of Amendment Act, the interested persons/bhumidhars of Award No. 25/84-85 announced on 24.8.84 are also entitled for payment of solatium @ 30% on the market value and 12% additional compensation w.e.f. - 27.7.81 i.o. date of notification u/s 4(1) of the Land Acquisition Act upto 24.8.84 i.e. date of announcement of Award No. 25/84-85.

As per above discussion the following amount is also allowed to the interested persons of Award-Ne. 25884-85 and this amount shall be apportioned as per original Award No. 25/84-85.
