PURPOSE OF ACQUISITION PLANNED DEVP. OF DELHI.

These are the supplementary proceedings of award No. 4A/83-84 announced on 30.6.83. After the announcement of above award, the Land Acquisition Act 1894 has been amended & the amendement came into force w.e.f. 24.9.84.

Unde the Amendment Act (68 of 1984) the provision of aub-section 23 have been amended by clause (b) of sec. 15 of the Amendment Act and which provides solatium @ 30% A new sub-section (1-A) of sec. 23 of the Principal Act has also been inserted by clause (a) of section 15 of the Amendment Act which provides 12% p.a. on the market value w.e.f. date of notification u/s 4(1) upto date of award of the Collector. Collector.

As per provisions of section 30 of the Amendment Act of 1984 the provisions of subsection (1-A) of section 23 of the Principal Act as inserted by clause (a) of section 15 of the Amendment Act and sub-section (2) of section 23 as amended by clause (b) of section 15 shall also apply in every proceedings for acquisition of any land under the Principal Act pending on the 30th day of April, 1982 (the date of introduction of Land Acquisition (Amendment) Bill 1982 in the House of People) in which no award has been made by the House of People) in which no award has been made by the Collector before that date.

Keeping in view of the provisions of Amendment Act, the interested persons/Bhumidhars of Aw. No. 4A/83-84 announced on 30.6.83 are also entitled for payment of solatium @ 30% on the market value & 12% addl. compensation w.e.f. 24.10.61 i.e. date of publication of notification u/s 4(1) of L.A. Act upto 30.6.83 i.e. date of announcement of award No. 4A/83-84.

As per above discussion the following amount is also allowed to the interested persons of Award No. 4A/83-84 & this amount shall be apportioned as per original Aw.No.4A/83
