#### 1. INTRODUCTION

These are proceedings for determination of compensation under Section 11 of Land Acquisition Act 1894 in respect of Land measuring 08 Biswa (Khasra No.754/21/2/2/2/2/2) (Old no.) (New khasra no. 1083-1149/754/21) of village Khampur Raya belonging to Shamlat Deh.

The proceedings were initiated on the basis of orders of Hon'ble High Court of Delhi in Civil Writ petition no. 2489/2001 titled Phool Singh & Others V/s UOI. Earlier, Slum & J.J. Department has taken the land without following the land acquisition proceedings. The interested person approached the Court and the Court ordered that as respondent has already utilized the land for public purpose, so, appropriate steps be taken for acquisition of land in question under the provisions of Land Acquisition Act,1894 by issuing a formal notification under Section 4.

The land is required by the Government for public purpose, namely, construction of Booster Pump by Slum & J.J. Department. The land was notified under Section 4 of Land Acquisition Act, 1894 vide notification No.F.10 (87)/02/L&B/LA/3885 dated 07.06.2004. Also, it was mentioned in this notification that provision of sub-section (1) of Section 17 of the said Act are applicable to this land and further under Section 17 (4), all the provisions of Section 5A shall not apply.

The Government issued declaration under Section 6 of Land Acquisition Act, 1894 vide notification No.F.10 (87)/02/L&B/LA/2607 dated 03.06.2005. In view of urgency of the scheme, the provision of Section 17(1) of the Land Acquisition Act, 1894 were also made applicable to this land vide notification No.F.10 (87)/02/L&B/LA/2608 dated 03.06.2005.

Notices under Section 9 & 10 of the Land Acquisition Act, 1894 were issued to the interested persons. In response to these notices, no. of claims were filed by the interested persons which have been discussed under the heading 'CLAIMS & EVIDENCE'.

## MEASUREMENT

The area to be acquired as given in the declaration under Section 6 of Land Acquisition Act, 1894 is 08 Biswa out of Khasra No. 754/21/2/2/2/2/2 min. (Old no.) (New khasra no. 1083-1149/754/21) min. of Khampur Raya Village. Actually the Khasra No. of the concerned land is 21 which is under the ownership of Shamlat Deh as per revenue record. The land of this Khasra has been acquired a number of times by different awards and accordingly the Khasra No. was broken number of times. It seems that old Khasra number was mentioned inadvertently but both the Khasra numbers are for the same land total measuring 332 Bigha & 7 Biswa. On physical survey conducted by a team of the staff of LAC (W), L&B Deptt., MCD & Slum & JJ the exact area of land to be acquired was found to be the same.

The claims from serial no. 1-237 have claimed Rs. 80,000/- per sq. yds along with other benefits permissible under the LA Act 1894 while the claimant at serial no. 238 has

filed claims for Rs. 1,00,000/- per sq. yds. along with other benefits under the Land Acquisition Act, 1894. These claimants have filed copy of award no. 1/DCW/2004-05, 13/DCW/2004-05 of Patel Nagar and the land was situated on the main road and the LAC has assessed the rate as Rs. 13,280/- per sq. mtr. Also, they have enclosed copy of Award no. 14/DCW/04-05 in which 21.6 sq. mtr. of land was acquired situated on main road Patel Nagar and the rate was assessed as Rs. 13,280/-per sq. mtr. Further, they have enclosed a copy of letter issued by SDM (Patel Nagar) mentioning the value of one property as Rs. 1 crore and an advertisement of DDA fixing the reserve price in West Patel Nagar as Rs. 26,877.

A notice under Section 50 was also given to the Addl. Commissioner, Slum & JJ and Tehsildar Slum & JJ appeared on behalf of Department on 26/04/06. It was informed that in the Award no. 3/2003-04 which was made a few years back, the LAC has assessed the market value as Rs. 821/- per sq. yd. for the land in village Khampur Raya. Also, the quality of land is very poor and it is hilly land without any proper road etc. This land falls in a congested unauthorized and unplanned colony and even approach road is not proper. The land has a very low value and cannot be compared at all with the land of East or West Patel Nagar or and specially, land situated on the main Patel Road in a planned locality which has high residential and commercial value.

### MARKET VALUE

### (A) LAND

While determining the market value of Land as on 07.06.2004 i.e. the date of notification issued under Section 4 of the Land Acquisition Act, 1894, several factors such as location of land, nature of soil, use of land, award announced in recent past of the same or adjoining Villages ,sale deeds, pronouncement of different Courts, Claims filed by interested persons & evidence adduced by requisitioning Govt. Deptt., if any, are to be taken into consideration.

Keeping the above facts in mind, the following methods for valuation of land under acquisition were followed.

In the first method, the schedule of rates circulated by the Deptt. of Urban Development, Ministry of Urban Affairs & Employment vide Letter No.J-22011/4/95/LD dated 16.04.99 was referred. It was noted that the indicative price of land in Patel Nagar (which is nearby (Revenue State – Khampur Raya)is Rs.11,550/- per sqm for residential land & Rs. 24,150/- for commercial land but Patel Nagar cannot be said to be a comparable colony as the land under acquisition is in Baljeet Nagar which is an unauthorized colony. In this aforesaid letter, it was also mentioned that rates for comparable areas will apply. In Zone-III, West Delhi there is no mention of Baljeet Nagar even Moti Nagar and Tihar I & II are in much better location, in which rate of residential land is Rs. 6,930/- and commercial land is Rs. 14,490/- per sqm. These rates were applicable till 31/03/2000.

In the second method of valuation, the price within a reasonable time frame in bonofide transactions of purchase of similar lands possessing similar advantage has been followed. So the details of registered sale deeds of the adjacent areas were collected to estimate the fair market value, which are detailed below:

On calculation, the average sale price of these last three transactions of 2004 comes to Rs.1,447/- per sqm. The registered sale deed value of the land in vicinity of the land under acquisition also shows that the value of the land being acquired has no comparison with the value of land of the colony Patel Nagar.

In another method of valuation, the awards of previous years of the said village were also taken into consideration. The details of past Awards of village Khampur Raya is as under: -

The average awarded value came as Rs.1607/- per Sq. Yard or Rs. 1922/- per sqm.

Further another Award No. 4/DCW/05-06 was announced recently in which date of notification under Section 4 was 17/03/2004 and the market value was assessed as Rs. 3500/- per Sqm.

By evaluating the above methods for determination of market value and keeping in view the claims filed by the interested persons and Slum & JJ Department, it is clear that it is not appropriate at all to consider the land value of Land requisitioned as the same or even nearly to the land acquired earlier on the main Patel Road which has very high

residential and commercial value and very high potential. As is clearly evident from the registered value of various registered deeds listed above that the average rate per sq. mtrs at which the land is being registered is very low and comes to approx. Rs. 1,447/-per sq. mtr. Further the quality of land is very poor and situated in a congested unauthorized and unplanned colony.

In view of this, the land under Acquisition cannot be compared at all with the land for which evidence was enclosed by the interested persons and their claims are exorbitantly high. Keeping the above in view, the market value of this land is assessed as Rs. 3,500/- per sq. mtr. Only.

#### B STRUCTURE

There is no structure of landowners standing on this land.

### C SOLATIUM

On the market value so determined by the LAC, the interested persons are entitled to get 30% Solatium as per the provisions of Land Acquisition Act, 1894.

#### D ADDITIONAL BENEFIT

The interested persons are entitled to get additional amount @12% p.a. on the market value of land U/s 23 (1-A) of the Land Acquisition Act, 1894 from the date of notification U/s 4 till the date of Award. In the present proceedings, the formal taking over and handing over proceedings were not carried out though the possession is already with the Slum & JJ Department. So, the additional amount @ 12% p.a. is calculated from 07/04/2004 to 02/06/2007.

#### E. APPORTIONMENT

The compensation will be paid to the rightful owners / interested persons on the basis of latest entries in the revenue records.
