

AWARD NO. 2182-E (suppl.)

NAME OF VILLAGE : MAHIPALPUR
NATURE OF ACQUISITION: PERMANENT
PURPOSE OF ACQUISITION: PLANNED DEVELOPMENT OF DELHI.

These are proceedings u/s 11 of the L.A. Act, 1894 for acquisition of land in Village Mahipalpur which is required by the Govt. at public expense for a public purpose namely for the Planned Development of Delhi. This land was notified u/s 4 of the L.A. Act vide notification No. F.4(98)/64-L&H dated 23.1.1965. The substance of this notification was given due publicity in the locality and the objections from the interested persons were invited. After hearing the objection a report u/s 5-A was submitted to the Delhi Administration. Thereafter a declaration u/s 6 of the said Act was issued vide notification No. F.4(98)/64-L&H(i) dated 7.12.66 for the land measuring 4769 Bigha 1 Biswas.

Out of land notified u/s 6 of L.A. Act, an area measuring 2 bigha 15 biswas is being acquired at present. The land measuring 144 Bighas was acquired through award No. 2182, area measuring 2437 bighas acquired through Award No. 2182-B, land measuring 61 bigha 2 biswas acquired under award No. 2182-C and an area of 971 bigha 7 biswas acquired through award No. 2182-D. An award for the land measuring 413 bighas 9 biswas has ~~already~~ also been drawn. The rest of the area measuring 739 bigha 8 biswas will be acquired through Supplementary award as and when required by the Government. Notices u/s 9 & 10 of the L.A. Act were also issued to the interested persons for filing their claims who have responded to the notices and have filed their claims which will be discussed under a separate heading "Claims & Evidence.". This award is supplement to the previous proceedings.

Rs. 50,000/- is claimed for injurious effect. Severence for the remaining land of the claimants and solatium + Instt. are also prayed for under the law.

MARKET VALUE

The market value of the land has to be assessed with respect to the date of preliminary notification which in this case is 23.1.1965. The market value has to reflect the potential of the land, which depends on its quality, location as well as the shape and size of the land. There have been awards in the past in the area, as such in order to arrive at a definite conclusion various factors have to be given consideration which includes sale deeds executed for similar pieces of land close to the date of notification and the awards already announced. Since, no evidence or proofs have been submitted by the claimants, as such no help is available from this aspect in calculating the market value and therefore the aforesaid two documents are to be taken as guidelines in this regard.

The Revenue Field Staff after consulting the records of the Sub Registrar office, New Delhi has quoted the following information so far as the sale deeds are concerned. Information based on the previous awards is also given below:-

The Khasra Nos. now under acquisition form part of Block 'B' as per the definition of land and blocks given in Award No. 2182-supplementary 'B'. For this in the said Award compensation was assessed @ Rs. 1900/- per bigha but as a result of appeal by the aggrieved interested persons the lower Court enhanced the amount from Rs. 1900 to Rs. 3100/-. We have considered Rs. 2500/- as reasonable rate and for Rs. 600/- an appeal has been filed and the same is awaiting decision. Taking all this into consideration I also feel that the rate of Rs. 2500/- is reasonable and justified and assess the same for the land under acquisition.

: 6 :

TREES & WELL :- There are no trees & Wells on the land under acquisition. Hence no compensation is assessed.

STRUCTURE :- There is no structure on the land under acquisition. The question of assessment of compensation does not arise.

INTEREST :- No interest is assessable to the land under acquisition to the persons interested as the possession of the land has not been taken over so far on record, but the Deptt. has dug the drain with the consent of the owners. No interest is payable u/s 4(3) in this case, because the declaration u/s 6 was made before three years from the date of notification u/s 4 i.e. 23.1.65. Supplementary award of interest u/s 32 will be drawn later on after the receipt of the date of digging drain from the concerned ~~Dept.~~ Deptt. (Flood Control Division no 1)

SOLATIUM :- 15 % solatium would be payable on the market value of the land being charges of compulsory acquisition of land.

LAND REVENUE :- The land revenue under acquisition is assessed to Rs. 0-72. The same will be deducted from the Knalsa Rent Roll of the Village from the date of taking over possession.

APPORTIONMENT :- Compensation will be paid to the recorded owners on the basis of latest entries in the revenue record. In case of dispute, if the parties do not reach an amicable settlement within a reasonable time, the compensation will be sent to the Court of ADJ for adjudication.
